#### A BILL ENTITLED

#### 1 AN ACT concerning

#### 2 Motor Vehicle Administration – Death Certificates – Issuance of Copies

FOR the purpose of authorizing the Motor Vehicle Administration to access electronically
from the Maryland Department of Health a copy of a death certificate and, on
request, provide any person authorized by regulations with a certified or abridged
copy of a death certificate; authorizing the Administration to set and collect a fee for
processing and issuing death certificates, subject to certain limitations; and
generally relating to the issuance of copies of death certificates.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

(a) (1) Except as provided in subsection (b) of this section, the Secretary shall
provide, on request, any person authorized by regulations adopted under this subtitle with
a certified or abridged copy of a birth, death, or fetal death certificate registered under this
subtitle or of the certificate of a marriage performed after June 1, 1951.

21 22 23 24 25	(ii) The fee set by the local health department or the Motor Vehicle Administration for processing and issuing a birth certificate or for a report under subparagraph (i) of this paragraph may not exceed the actual costs to the local health department or the Motor Vehicle Administration for processing and issuing a birth certificate or a report.
26 27 28	(iii) From the fee the local health department or the Motor Vehicle Administration collects under subparagraph (i) of this paragraph, \$10 shall be transferred to the General Fund.
29 30 31 32 33	(iv) Prior to setting and collecting a fee for processing and issuing a birth certificate or for a report under subparagraph (i) of this paragraph, the local health department or the Motor Vehicle Administration shall enter into a memorandum of understanding with the Maryland Department of Health that outlines the local health department's or the Motor Vehicle Administration's fee structure.

45	(5) The Secretary may waive all or part of a fee if chargeable to an agency of the United States.

8 9	1. A current or former member of the armed forces of the United States; or

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 October 1, 2024.
