A BILL ENTITLED

1 AN ACT concerning

2 **Aquaculture – Placement of Shellfish, Bags, Nets, and Structures on Submerged**
3 **Aquatic Vegetation – Extension**

4 FOR the purpose of extending the authorization of a leaseholder of certain aquaculture
5 leases to, with prior written approval from the Department of Natural Resources,
6 place shellfish, bags, nets, and structures on submerged aquatic vegetation, subject
7 to certain requirements; and generally relating to aquaculture leases and submerged
8 aquatic vegetation.

15 Chapter 238 of the Acts of the General Assembly of 2019

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

Article – Natural Resources

20 4–11A–10.

21 (c) A leaseholder may not:

1 (1) Place shellfish, bags, nets, or structures on submerged aquatic
2 vegetation without prior written approval from the Department;

3 (2) Plant or harvest shellfish within 500 yards of any stationary blind or
4 blind site that is occupied and being used for hunting migratory waterfowl;

5 (3) Sublease a lease;

6 (4) Transfer a lease without the approval of the Department;

7 (5) Harvest shellfish between the hours of sunset and sunrise; or

8 (6) Place unlawfully harvested oysters on a lease.

9 (c-1) In approving the placement of shellfish, bags, nets, or structures on
10 submerged aquatic vegetation under subsection (c)(1) of this section, the Department:

11 (1) May not authorize harvesting by dredge in areas where submerged
12 aquatic vegetation is present;

13 (2) Shall authorize for water column leases the placement of shellfish,
14 bags, nets, or structures in at least 10% of the area where submerged aquatic vegetation is
15 present; and

16 (3) Shall authorize harvest by diving in areas on any submerged land lease
17 where submerged aquatic vegetation is present.

18 **Chapter 238 of the Acts of 2019**

19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June
20 1, 2019. It shall remain effective for a period of [5] 8 years and 1 month and, at the end of
21 June 30, [2024] 2027, this Act, with no further action required by the General Assembly,
22 shall be abrogated and of no further force and effect.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
24 1, 2024.
