22 23 24	(d) (1) [For each of fiscal years 2023 through 2025] <b>BEGINNING IN FISCAL YEAR 2025 AND EACH FISCAL YEAR THEREAFTER</b> , the Governor shall include in the annual budget bill an appropriation of \$3,700,000 to the Program.
25 26	(2) In awarding grants under the Program, the Department shall distribute:
27 28	(i) \$1,283,000 to existing providers in the same amount as was provided in fiscal year 2022;
29 30	(ii) \$1,917,000 to existing providers in the same proportion as was provided in fiscal year 2022 to provide additional services; and

- 1 (iii) Except as provided in paragraph (3) of this subsection, \$500,000 2 to new providers or existing providers to enroll additional children.
- 3 (3) If funds are remaining after the distribution required under paragraph (2)(iii) of this subsection, then the remainder shall be distributed as provided under paragraph (2)(ii) of this subsection.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 7 1, 2024.
