CHAPTER _____

1 AN ACT concerning

2 **Growing Apprenticeships and the Public Safety Workforce (GAPS) Act**

3 FOR the purpose of altering the Law Enforcement Cadet Apprenticeship Program in the
4 Maryland Department of Labor to be the Public Safety Apprenticeship Program;
5 expanding the purpose and scope of the Program to promote careers with certain
6 public safety agencies; ~~increasing the maximum amount of a grant~~ altering the
7 eligibility criteria and the types of grants that may be awarded under the Program;
8 requiring the Maryland Police Training and Standards Commission to develop
9 certain mental health wellness policies to be implemented in certain law
10 enforcement agencies and correctional facilities; establishing the Workgroup on
11 Growing Engagement in the Law Enforcement and the Corrections Workforce to
12 study and make recommendations on increasing law enforcement employment in the
13 State; and generally relating to the Public Safety Apprenticeship Program, the
14 duties of the Maryland Police Training and Standards Commission, and the
15 Workgroup on Growing Engagement in the Law Enforcement and the Corrections
16 Workforce.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 12 That the Laws of Maryland read as follows:

13 **Article – Labor and Employment**

14 11–603.

15 (a) (1) In this section the following words have the meanings indicated.

16 [(2) “Cadet Program” means the Law Enforcement Cadet Apprenticeship
 17 Program.]

18 [(3)] (2) “Law enforcement agency” means the police department of a
 19 county, municipal corporation, [or] university in the State, **OR STATE AGENCY.**

20 (3) **“PROGRAM” MEANS THE PUBLIC SAFETY APPRENTICESHIP
 21 PROGRAM.**

22 (4) **“PUBLIC SAFETY AGENCY” INCLUDES:**

23 (I) **A CORRECTIONAL UNIT, AS DEFINED IN § 2–401 OF THE
 24 CORRECTIONAL SERVICES ARTICLE;**

25 (II) **A LAW ENFORCEMENT AGENCY; AND**

26 (III) **A PUBLIC SAFETY AGENCY, AS DEFINED IN § 1–301 OF THE
 27 PUBLIC SAFETY ARTICLE.**

28 (b) There is a [Law Enforcement Cadet] **PUBLIC SAFETY** Apprenticeship
 29 Program in the Department.

30 (c) The purposes of the [Cadet] Program are to:

1 (1) provide young individuals opportunities to begin a career [in law
2 enforcement] **WITH A PUBLIC SAFETY AGENCY;**

3 (2) foster positive relationships between the public, particularly young
4 individuals, and [law enforcement] **PUBLIC SAFETY** agencies;

5 (3) develop a cohort of individuals qualified to join a [law enforcement]
6 **PUBLIC SAFETY** agency;

7 (4) encourage [law enforcement] **PUBLIC SAFETY** agencies to hire
8 apprentices; and

9 (5) help [law enforcement] **PUBLIC SAFETY** agencies offset additional
10 costs, if any, associated with hiring apprentices.

11 (d) **THE PROGRAM SHALL CONSIST OF START-UP GRANTS AND**
12 **STABILIZATION GRANTS.**

13 (e) **A PUBLIC SAFETY AGENCY OR A GROUP OF PUBLIC SAFETY AGENCIES**
14 **PARTICIPATING IN THE PROGRAM SHALL:**

15 (1) **DEVELOP A REGISTERED APPRENTICESHIP PROGRAM; AND**

16 (2) **ESTABLISH A REGISTERED APPRENTICESHIP PROGRAM THAT**
17 **DEVELOPS A CAREER PATH THAT ENABLES AN INDIVIDUAL TO WORK IN A PUBLIC**
18 **SAFETY AGENCY.**

19 (f) (1) The Department shall:

20 (i) administer the [Cadet] Program; and

21 (ii) award **START-UP AND STABILIZATION** grants under the
22 [Cadet] Program on a competitive basis to ~~[law enforcement] PUBLIC SAFETY agencies~~
23 ~~that meet the requirements under paragraph (2) of this subsection~~ **A PUBLIC SAFETY**
24 **AGENCY OR A GROUP OF PUBLIC SAFETY AGENCIES THAT MEET THE REQUIREMENTS**
25 **OF THIS SECTION.**

26 (2) (i) **EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
27 **PARAGRAPH, THE DEPARTMENT MAY AWARD:**

28 1. **A START-UP GRANT NOT EXCEEDING \$200,000 TO A**
29 **PUBLIC SAFETY AGENCY OR A GROUP OF PUBLIC SAFETY AGENCIES FOR**

 7 **GROUP OF PUBLIC SAFETY AGENCIES THAT FAIL TO BARGAIN WITH THE**
 8 **APPROPRIATE EXCLUSIVE REPRESENTATIVE REGARDING ANY ADJUSTMENTS TO**
 9 **WAGES, HOURS, OR OTHER TERMS AND CONDITIONS OF EMPLOYMENT THAT ARE**
 10 **REQUIRED FOR INDIVIDUALS TO PARTICIPATE IN THE PUBLIC SAFETY AGENCY'S**
 11 **REGISTERED APPRENTICESHIP PROGRAM.**

15 (b) “Commission” means the Maryland Police Training and Standards
16 Commission.

17 (d) (1) “Law enforcement agency” means a governmental police force, sheriff’s
18 office, or security force or law enforcement organization of the State, a county, or a
19 municipal corporation that by statute, ordinance, or common law is authorized to enforce
20 the general criminal laws of the State.

21 (2) “Law enforcement agency” does not include members of the Maryland
22 National Guard who:

23 (i) are under the control and jurisdiction of the Military
24 Department;

25 (ii) are assigned to the military property designated as the Martin
26 State Airport; and

27 (iii) are charged with exercising police powers in and for the Martin
28 State Airport.

1 (M) (1) IN THIS SUBSECTION, "CORRECTIONAL FACILITY" MEANS A
 2 STATE CORRECTIONAL FACILITY AND A LOCAL CORRECTIONAL FACILITY, AS
 3 DEFINED IN § 1-101 OF THE CORRECTIONAL SERVICES ARTICLE.

4 (2) THE COMMISSION SHALL DEVELOP MENTAL HEALTH WELLNESS
 5 POLICIES TO BE IMPLEMENTED IN LAW ENFORCEMENT AGENCIES AND
 6 CORRECTIONAL FACILITIES IN THE STATE BY:

 18 ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL

22 SECTION 2. AND BE IT FURTHER ENACTED, That:

23 (a) There is a Workgroup on Growing Engagement in the Law Enforcement and
 24 the Corrections Workforce.

25 (b) The Workgroup consists of the following members:

26 (1) one member of the Senate of Maryland, appointed by the President of
 27 the Senate;

28 (2) one member of the House of Delegates, appointed by the Speaker of the
 29 House;

30 (3) the Secretary of Public Safety and Correctional Services, or the
 31 Secretary's designee;

1 ~~(2)~~ (4) the Secretary of Higher Education, or the Secretary's designee;

2 ~~(3)~~ (5) the Executive Director of the Maryland Association of Counties, or the
3 Executive Director's designee;

4 ~~(4)~~ (6) the Chief Executive Officer of the Maryland Municipal League, or the
5 Chief Executive Officer's designee;

6 ~~(5)~~ (7) the Executive Director of the Maryland Association of Community
7 Colleges, or the Executive Director's designee;

8 ~~(6)~~ (8) the State Superintendent of Schools, or the Superintendent's designee;

20 (ii) one county member of MCAA.

21 (c) The Governor shall designate the Chair of the Workgroup.

22 (d) The Maryland Police Training and Standards Commission shall staff the
23 Workgroup.

24 (e) A member of the Workgroup or any subgroup established under subsection (g)
25 of this section:

26 (1) may not receive compensation as a member of the Workgroup or
27 subgroup; but

28 (2) is entitled to reimbursement for expenses under the Standard State
29 Travel Regulations, as provided in the State budget.

(f) The Workgroup shall:

(1) identify and study the shortage of employees in the law enforcement and corrections fields;

(2) determine ways to advertise and promote law enforcement and corrections employment opportunities across the State; ~~and~~

(3) explore recruitment and retention strategies used in the law enforcement and corrections fields that have been successful in other states and countries; and

(4) make recommendations on incentives or other methods to increase the number of employees in the law enforcement and corrections workforce.

(g) (1) The Workgroup may establish a subgroup within the Workgroup to assist the Workgroup in carrying out its duties, including by conducting research and producing reports.

(2) A subgroup established under paragraph (1) of this subsection may include an individual who is not a member of the Workgroup.

(h) On or before January 1, 2025, the Workgroup shall report its findings and recommendations to the Governor and, in accordance with § 2–1257 of the State Government Article, the General Assembly.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act may not be construed as reducing or lowering the minimum qualifications for employment in a public safety agency, as defined in § 11–603(a)(4) of the Labor and Employment Article, as enacted by this Act.

~~SECTION 3.~~ SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2024. Section 2 of this Act shall remain effective for a period of 1 year and 1 month and, at the end of June 30, 2025, Section 2 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
