A BILL ENTITLED

1 AN ACT concerning

2 **Department of Juvenile Services – Report on Shootings**
3 **(Department of Juvenile Services Transparency Act of 2024)**

4 FOR the purpose of requiring the Department of Juvenile Services to report certain
5 information regarding shootings of and by juveniles under the supervision of the
6 Department to the Maryland General Assembly; and generally relating to the
7 Department of Juvenile Services.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Human Services**

16 **9–247.**

17 **(A) ON OR BEFORE DECEMBER 1, 2024, AND EACH DECEMBER 1**
18 **THEREAFTER, THE DEPARTMENT SHALL REPORT, IN ACCORDANCE WITH § 2–1257**
19 **OF THE STATE GOVERNMENT ARTICLE, TO THE GENERAL ASSEMBLY ON:**

20 **(1) THE NUMBER OF JUVENILES UNDER THE DEPARTMENT’S**
21 **SUPERVISION IN THE PRECEDING YEAR WHO:**

22 **(I) WERE NONFATALLY SHOT;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(II) SHOT ANOTHER INDIVIDUAL; OR**

2 **(III) WERE VICTIMS OF A HOMICIDE;**

3 **(2) THE ACTIONS THAT THE DEPARTMENT TOOK AFTER THE**
4 **INCIDENTS DESCRIBED IN ITEM (1) OF THIS SUBSECTION, INCLUDING THE TIMELINE**
5 **OF THE ACTIONS;**

6 **(3) THE AGE OF EACH JUVENILE DESCRIBED IN ITEM (1) OF THIS**
7 **SUBSECTION; AND**

8 **(4) THE COUNTY OF RESIDENCE OF EACH JUVENILE DESCRIBED IN**
9 **ITEM (1) OF THIS SUBSECTION.**

10 **(B) THE INITIAL REPORT SUBMITTED UNDER THIS SECTION SHALL**
11 **INCLUDE A DESCRIPTION OF ANY ESTABLISHED PROCESS THAT THE DEPARTMENT**
12 **USES AFTER AN INCIDENT DESCRIBED IN SUBSECTION (A)(1) OF THIS SECTION**
13 **OCCURS.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2024.
