A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Fees for Class C Per Diem**
3 **Licenses**

4 FOR the purpose of increasing in Anne Arundel County the fees for certain Class C per
5 diem alcoholic beverages licenses when issued for a 1–day event with more than a
6 certain number of attendees; and generally relating to alcoholic beverages and
7 license fees in Anne Arundel County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages and Cannabis**

21 4–1203.

22 (a) A Class C per diem beer license or a Class C per diem beer and wine license
23 entitles the license holder to exercise any of the privileges conferred by the respective class
24 of license:

1 (1) for the use of a person holding an entertainment event that is conducted
2 by a club;

3 (2) at the place described in the license; and

4 (3) for a period not exceeding 7 consecutive days.

6 (a) A Class C per diem beer, wine, and liquor license entitles the license holder to
7 exercise any of the privileges conferred by this class of license:

8 (1) for the use of a person holding an entertainment event that is conducted
9 by a club;

10 (2) at the place described in the license; and

11 (3) for a period not exceeding 7 consecutive days.

12 11–102.

13 This title applies only in Anne Arundel County.

14 11–1311.

15 (a) **(1) [The] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
16 **SUBSECTION, THE** fee for a Class C per diem beer license and a Class C per diem beer and
17 wine license is \$25 per day.

18 **(2) FOR A 1–DAY EVENT WITH MORE THAN 1,000 ATTENDEES, THE**
19 **FEE FOR A CLASS C PER DIEM BEER LICENSE AND A CLASS C PER DIEM BEER AND**
20 **WINE LICENSE IS \$500.**

21 (b) **(1) [The] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
22 **SUBSECTION, THE** fee for a Class C per diem beer, wine, and liquor license is \$50 per day.

23 **(2) FOR A 1–DAY EVENT WITH MORE THAN 1,000 ATTENDEES, THE**
24 **FEE FOR A CLASS C PER DIEM BEER, WINE, AND LIQUOR LICENSE IS \$1,000.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
26 1, 2024.
