### CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **County Boards of Education – Budgets – Notice**  
3 **(Transparency in Education Spending Act)**

4 FOR the purpose of requiring the State Board of Education to adopt a process for the  
5 uniform and timely reporting of certain county board of education budget  
6 information to a county governing body; requiring a county board to post certain  
7 information in a certain manner on the county board’s website; ~~requiring a certain~~  
8 ~~transfer to be made only following the approval of the county commissioners or the~~  
9 ~~county council; providing for exemptions from certain requirements related to~~  
10 ~~certain transfers;~~ requiring a certain audit to be sent to the county council or the  
11 county commissioners; and generally relating to the budgets of county boards of  
12 education.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
10 That the Laws of Maryland read as follows:

11 **Article – Education**

12 5–101.

13 (a) (1) Subject to the rules and regulations of the State Board and with the  
14 advice of the county superintendent, each county board shall prepare an annual budget  
15 according to:

16 (i) The major categories listed in this section; and

17 (ii) Any other major category required by the State Board.

18 (2) In addition to the information required by this section, the county fiscal  
19 authorities may require the county board to provide details to the service areas and  
20 activities levels in the account structure within the “Financial Reporting Manual for  
21 Maryland Public Schools”.

22 (3) With the annual budget, each county board shall provide:

23 (i) The number of full–time equivalent positions included within  
24 each major category; and

25 (ii) A description of any fund balances or other money held by any  
26 outside source, including an insurer, that are undesignated or unreserved and are under  
27 the direction and control of the county board.

28 **(4) THE STATE BOARD SHALL ADOPT A PROCESS FOR THE UNIFORM**  
29 **REPORTING OF THE INFORMATION IN SUBSECTION (B) OF THIS SECTION TO TIMELY**  
30 **SHARE THE INFORMATION PROVIDED BY A COUNTY BOARD IN SUBSECTION (B) OF**  
31 **THIS SECTION TO A COUNTY GOVERNING BODY.**

32 (b) The budget shall be prepared to include the following categories:

2 (1) Current expense fund, estimated receipts:

3 (i) Revenue from local sources;

4 (ii) Revenue from State sources;

5 (iii) Revenue from federal sources;

6 (iv) Unliquidated surplus, the actual from the previous fiscal year  
7 and the estimated from the current fiscal year, whether accrued from revenues or  
8 expenditures; and

9 (v) Revenue from all other sources with identification of the source.

10 (2) Current expense fund, requested appropriations:

11 (i) Administration, which means those activities associated with the  
12 general regulations, direction, and control of the county board, including:

13 1. Executive administration;

14 2. Business support services; and

15 3. Centralized support services;

16 (ii) Mid-level administration, including:

17 1. The office of the school principal; and

18 2. Staff providing administration and supervision to the  
19 school instructional programs;20 (iii) Instructional salaries, which means those activities which deal  
21 directly with teaching students, including:

22 1. Teachers;

23 2. Aides;

24 3. Psychological personnel;

25 4. Guidance counselors; and

26 5. Library personnel;

- 3 (vi) Special education with subcategories and items budgeted in this

22 (vii) An amount that is adequate to satisfy a final court judgment

 24 education or any of its officers or employees.

26 (a) In this subtitle, “county council” means, in Baltimore City, the Mayor and City  
 27 Council of Baltimore.

1 (b) (1) Each county board shall submit an annual school budget in writing to  
2 the county commissioners, county council, or county executive.

3 (2) The budget shall be submitted not less than 45 days before the date for  
4 levying local taxes or on an earlier date on or after March 1 as may be requested by the  
5 county fiscal authority.

6 (e) (1) Copies of the budget shall be made available to the public, on request,  
7 at the time it is submitted by the county board.

8 (2) A copy of the budget as approved by the county commissioners or county  
9 council shall be sent to the State Superintendent within 30 days after approval AND  
10 POSTED ON THE COUNTY BOARD'S PUBLIC-FACING WEBSITE, IN AN EASILY  
11 IDENTIFIABLE LOCATION.

13 (a) (1) Each county board shall make the reports required by the State Board  
14 and by the State Superintendent.

15 (2) The reports shall be made at the time, include the items, and be on the  
16 forms required by the State Board and by the State Superintendent.

17 (b) (1) Each county board shall prepare, publish, and make available to  
18 interested parties an annual report on the condition, current accomplishments, and needs  
19 for improvement of the schools as well as a statement of the business and financial  
20 transactions of the county board.

21 (2) This report shall be published before the end of the calendar year.

22 (c) The public schools of each county shall use a uniform method, as required by  
23 the county superintendent, for reporting the receipts, expenditures, and balances of the  
24 operations and activities conducted by the public schools.

25 (d) (1) At the request of the county governing body made in writing at least 30  
26 days before the reporting deadline, the county board or superintendent shall report to the  
27 county governing body on or before November 1 and March 1 of each fiscal year on the  
28 school system's operations, including any adjustment made to the approved annual budget  
29 **AND POST THE REPORT ON THE COUNTY BOARD'S PUBLIC-FACING WEBSITE, IN AN**  
30 **EASILY IDENTIFIABLE LOCATION.**

31 (2) A report under this subsection shall be made available to all interested  
32 persons.



1 (e) (1) At the request of the county board made in writing at least 30 days  
2 before the reporting deadline the county governing body shall report to the county board on  
3 or before November 1 and March 1 of each fiscal year on the county’s fiscal status for the  
4 immediate fiscal year and the subsequent fiscal year **AND POST THE REPORT ON THE**  
5 **COUNTY BOARD’S PUBLIC-FACING WEBSITE, IN AN EASILY IDENTIFIABLE LOCATION.**

6 (2) A report under this subsection shall be made available to all interested  
7 persons.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
9 1, 2024.
