A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Fees**

3 FOR the purpose of increasing alcoholic beverages license and permit fees paid to the Board
4 of License Commissioners for Anne Arundel County; and generally relating to
5 alcoholic beverages license and permit fees in Anne Arundel County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Alcoholic Beverages and Cannabis**

4 11–102.

5 This title applies only in Anne Arundel County.

6 11–701.

7 (a) There is a Class A light wine license in the county.

8 (d) The annual license fee is ~~[\$60]~~ **\$81**.

9 11–801.

10 (a) There is a Class A beer and light wine license.

11 (c) The annual license fee is ~~[\$240]~~ **\$324**.

12 11–802.

13 (a) There is a Class B beer and light wine license.

14 (d) The annual license fee is ~~[\$480]~~ **\$648**.

15 11–803.

16 (a) There is a Class C beer and light wine license.

17 (c) The annual license fee is ~~[\$120]~~ **\$162**.

18 11–804.

19 (a) There is a Class D beer and light wine license.

20 (d) The annual license fee is ~~[\$480]~~ **\$648**.

21 11–805.

22 (a) There is a Class H beer and light wine license.

23 (d) The annual license fee is ~~[\$360]~~ **\$486**.

1 (a) There is a beer and wine (hotel–limited service) license.

2 (d) The annual license fee is ~~[\$2,400]~~ **\$3,240** to be paid on or before May 1.

4 (a) There is a Class A beer, wine, and liquor license.

5 (d) The annual license fee is ~~[\$720]~~ **\$972**.

7 (a) There is a Class B beer, wine, and liquor license.

8 (e) The annual fee for the license is ~~[\$1,080]~~ **\$1,458**.

10 (a) There is a Class C beer, wine, and liquor license.

11 (c) The annual license fee is ~~[\$480]~~ **\$648**.

12 11–904.

13 (a) There are:

14 (1) a Class D beer, wine, and liquor license for on– and off–premises
15 consumption; and

16 (2) a limited Class D beer, wine, and liquor license for on–premises
17 consumption only.

18 (c) The annual license fees are:

19 (1) ~~[\$1,200]~~ **\$1,620** for a Class D license; and

20 (2) ~~[\$1,080]~~ **\$1,458** for a limited Class D license.

21 11–905.

22 (a) There is a Class H beer, wine, and liquor license.

23 (e) The annual license fee is ~~[\$960]~~ **\$1,296**.

24 11–906.

1 (a) There is a beer, wine, and liquor (hotel-limited service) license.

2 (d) The annual license fee is [~~\$2,800~~] **\$3,780**.

3 11-907.

4 (a) There is a motel/hotel-restaurant license.

5 (d) The annual license fee is [~~\$3,600~~] **\$4,860** for each separate establishment.

6 11-1001.

7 (a) There is an airport concessionaire license.

8 (f) (1) (i) The annual fee for the license and one location from which
9 alcoholic beverages may be sold is [~~\$5,000~~] **\$6,750**.

10 (ii) The annual fee for each additional location from which alcoholic
11 beverages may be sold is [~~\$5,000~~] **\$6,750**.

12 (2) Each fee shall be paid on or before May 1 to the Board.

13 11-1002.

14 (a) There is a barbershop and beauty salon beer and wine license.

15 (f) The annual license fee is [~~\$100~~] **\$135**.

16 11-1002.1.

17 (b) There is a commercial bingo license.

18 (g) The annual license fee is [~~\$2,500~~] **\$3,375**.

19 11-1002.2.

20 (a) There is a Class C (country and golf club) license.

21 (f) The annual license fee is [~~\$1,800~~] **\$2,430**.

22 11-1003.

23 (a) There is a Class C (country club) license.

24 (e) The annual license fee is [~~\$750~~] **\$1,012**.

1 11-1004.

2 (b) There is an entertainment concessionaire license.

3 (g) (1) The annual fee for the license is [~~\$5,000~~] **\$6,750**.

4 (2) The fee shall be paid on or before May 1 to the Board.

5 11-1005.

6 (b) There is an entertainment facility license.

7 (g) (1) The annual fee for the license is [~~\$15,000~~] **\$20,250**.

8 (2) The fee shall be paid on or before May 1 to the Board.

9 11-1006.

10 (a) There is a Class C (fraternal/sororal) organization license.

11 (e) The annual license fee is [~~\$400~~] **\$540**.

12 11-1006.1.

13 (a) There is a gift basket permit.

14 (h) The fee for a gift basket permit is [~~\$100~~] **\$135**.

15 11-1006.2.

16 (a) There is a Class MT (movie theater) beer and wine license.

17 (h) The annual license fee is [~~\$1,200~~] **\$1,620**.

18 11-1007.

19 (a) There is a racetrack license.

20 (g) The annual license fee is [~~\$25,000~~] **\$33,750** to be paid to the Board on or
21 before January 1 for the racing of the preceding year.

22 11-1007.1.

23 (a) There is a racetrack concessionaire license.

1 (f) The annual license fee is [~~\$5,000~~] **\$6,750**.

2 11-1008.

3 (b) There is a resort complex license.

4 (f) (1) The annual license fee is [~~\$1,800~~] **\$2,430**.

5 (2) The fee shall be paid on or before May 1 to the Board.

6 11-1008.1.

7 (a) There is a Class C (small yacht club) license.

8 (g) The annual license fee is [~~\$525~~] **\$709**.

9 11-1009.

10 (a) There is a Class C (veterans' organization) license.

11 (e) The annual license fee is [~~\$400~~] **\$540**.

12 11-1010.

13 (a) There is a Class C (yacht club) license.

14 (f) The annual license fee is [~~\$1,800~~] **\$2,430**.

15 11-1102.

16 (a) (1) On the premises, or on adjacent property over which a license holder
17 has ownership or control, a license holder:

18 (i) may allow piped-in background music or one television screen;
19 but

20 (ii) unless issued a permit described in this section that authorizes
21 the activity, may not allow:

22 1. the playing of music, including live music;

23 2. the operation of a karaoke machine;

24 3. the playing of music by a disc jockey; or

25 4. dancing, floor shows, or any other similar type of
26 entertainment.

3. music by a disc jockey.

(4) The permit holder may not allow dancing, floor shows, or similar live entertainment.

(5) The annual permit fees are:

(i) ~~[\$200]~~ **\$270** for a holder of a beer and wine license; and

(ii) ~~[\$300]~~ **\$405** for a holder of a beer, wine, and liquor license.

(d) (1) There is a dancing permit.

(2) The Board may issue the permit to a holder of:

(i) a Class B license;

(ii) except as provided in paragraph (4) of this subsection, a Class BLX license;

(iii) a Class C license;

(iv) a Class D license; or

(v) except as provided in paragraph (4) of this subsection, a Class H license.

(3) The permit authorizes the holder to provide music, dancing, and other legal forms of entertainment.

(4) The Board may not issue the permit to a holder of a Class BLX license or a Class H license if the premises for which the Class BLX license or Class H license is issued is within 1,000 feet in a straight line from entry to entry from a place of worship or school.

(5) The annual permit fees are:

(i) ~~[\$200]~~ **\$270** for a holder of a beer and wine license;

(ii) ~~[\$400]~~ **\$540** for a holder of a beer, wine, and liquor license; and

(iii) no charge for a holder of a Class C license.

(e) (1) There is an outdoor permit.

1 (2) The Board may issue the permit to a holder of a Class B license, a Class
2 BLX license, a Class C license, a Class D license, or a Class H license.

3 (3) The permit authorizes the holder to provide outdoor table service to
4 customers on the grounds of the licensed establishment.

5 (4) The annual permit fee is [~~\$100~~] **\$135**.

6 (5) Before the permit may be renewed, a holder shall obtain approval from
7 the Board.

8 (f) (1) There is an outdoor entertainment permit.

9 (2) The Board may issue the permit to a holder of a Class B license, a Class
10 BLX license, a Class C license, a Class D license, or a Class H license who also holds a
11 music permit, an entertainment permit, or a dancing permit under this section.

12 (3) The permit authorizes the holder to provide:

13 (i) the same form of entertainment outdoors that the holder is
14 allowed to provide indoors under the holder's music permit, entertainment permit, or
15 dancing permit; and

16 (ii) outdoor table service or cafe service.

17 11-1103.

18 (a) The Board may issue a refillable container permit for draft beer to a holder of
19 a Class A license, a Class B license, or a Class D license.

20 (e) The annual permit fees are:

21 (1) [~~\$50~~] **\$67** for an applicant whose license has an off-sale privilege; and

22 (2) [~~\$500~~] **\$675** for an applicant whose license does not have an off-sale
23 privilege.

24 11-1103.1.

25 (a) The Board may issue a nonrefillable container permit for draft beer to a holder
26 of a Class A license, a Class B license, or a Class D license.

27 (e) (1) Except as provided in paragraph (2) of this subsection, the annual
28 permit fees are:

29 (i) [~~\$50~~] **\$67** for an applicant whose license has an off-sale
30 privilege; and

1 (ii) **[\$500] \$675** for an applicant whose license does not have an
2 off-sale privilege.

3 (2) An applicant who has a refillable container permit may not be charged
4 a fee for a nonrefillable container permit.

5 11-1104.

6 (b) There is a Sunday permit.

7 (f) The annual permit fees are:

8 (1) **[\$60] \$81** for a beer and light wine Sunday permit; and

9 (2) **[\$120] \$162** for a beer, wine, and liquor Sunday permit.

10 11-1305.

11 (a) There is a Class WS wine sampling license.

12 (g) The license fee is **[\$15] \$20** per day.

13 11-1306.

14 (a) There is a Class WT wine tasting license.

15 (e) The annual license fee is:

16 (1) **[\$50] \$67** for a holder of a Class BW license; and

17 (2) **[\$150] \$202** for a holder of a Class BWL license.

18 11-1307.

19 (a) There is a BWT beer and wine tasting license.

20 (e) In addition to the Class A annual fee, the annual license fee is **[\$150] \$202**.

21 11-1308.

22 (a) There is a BWLT beer, wine, and liquor tasting license.

23 (e) In addition to the Class A annual fee, the annual license fee is **[\$500] \$675**.

24 11-1311.

1 (a) The fee for a Class C per diem beer license and a Class C per diem beer and
2 wine license is [~~\$25~~] **\$34** per day.

3 (b) The fee for a Class C per diem beer, wine, and liquor license is [~~\$50~~] **\$67** per
4 day.

5 11–1608.

6 (b) The Board may issue a 7–day Class BLX deluxe restaurant on–sale beer, wine,
7 and liquor license.

8 (h) The annual license fee is [~~\$1,200~~] **\$1,620**.

9 11–1703.

10 (a) This section does not apply to a club license.

11 (b) The fee for a transfer of location or ownership of a license is [~~\$200~~] **\$270**.

12 11–1802.

13 An applicant for a license renewal shall pay to the local collecting agent a
14 nonrefundable renewal fee of [~~\$50~~] **\$67** in addition to the annual license fee.
