Budget and Taxation

Prince George's County – Mobile Sports Wagering Proceeds – Local Impact Grant

This bill requires a mobile sports wagering licensee that is part of an ownership group that operates a video lottery facility in Prince George's County to pay the first \$3.5 million of proceeds retained by the mobile sports wagering licensee to the Comptroller to be distributed as local impact grants to nonprofit organizations and municipalities located within six miles of the video lottery facility. **The bill takes effect July 1, 2024.**

Fiscal Summary

State Effect: Special fund revenues and expenditures for local impact grants increase by \$3.5 million annually beginning in FY 2025.

Local Effect: Prince George's County revenues and expenditures increase by \$3.5 million annually beginning in FY 2025 as a result of receiving local impact grants and distributing them to nonprofit organizations and municipalities.

Small Business Effect: Minimal.

Analysis

Current Law: Chapter 492 of 2020 authorized sports and event wagering generally, subject to voter referendum, which was approved by Maryland voters in November 2020. The Act also provided that revenues from sports and event wagering must primarily be used for public education. Chapter 356 of 2021 implemented sports and event wagering in the State and provided for regulation of sports wagering by the State Lottery and Gaming Control Commission. The Act also established the Sports Wagering Application Review Commission (SWARC) to review and award applications for sports wagering facility and mobile sports wagering licensure.

Specified Class A and Class B sports wagering facility licensees designated under the law (casinos, professional sports stadiums, horse racing tracks, off-track facilities, and specified bingo halls) are eligible to receive licenses under a noncompetitive process. SWARC may also conduct a competitive process to award an additional 30 Class B-1 or B-2 facility licenses and 60 mobile sports wagering licenses.

Licensees retain 85% of sports wagering proceeds, with the remainder distributed to the Blueprint for Maryland's Future Fund (BMFF). Revenues accruing to BMFF are to be used to provide a world-class education for early childhood and K-12 students so that they are prepared for college and a career in the global economy.

Local Impact Grants

From the video lottery terminal proceeds at each facility, generally 5.5% are distributed as local impact grants to local governments in which a video lottery facility is operating. The grants are distributed by the Division of Racing within the Maryland Department of Labor.

Generally, local impact grants must be used for infrastructure improvements; facilities; public safety; sanitation; economic and community development, including housing; and other public services and improvements primarily in the communities in immediate proximity to the video lottery facilities.

Additionally, 5% of table game revenues are distributed to local jurisdictions where a video lottery facility is located.

Appendix – **Maryland Gaming** provides the status of gaming in Maryland as of December 2023.

State Fiscal Effect: Special fund revenues and expenditures for local impact grants to Prince George's County increase by \$3.5 million annually beginning in fiscal 2025.

Local Fiscal Effect: Local impact grant revenues and expenditures to Prince George's County increase by \$3.5 million annually beginning in fiscal 2025. Prince George's County must distribute the funds as local impact grants to nonprofit organizations and municipalities located within six miles of the video lottery facility.

Additional Comments: The mobile sports wagering licensee operating a video lottery facility in Prince George's County, BetMGM Maryland Sports LLC, launched in November 2022. The mobile sports wagering licensee had a taxable win of \$7.1 million in fiscal 2023 and a taxable win of \$9.9 million for the first half of fiscal 2024. Assuming the licensee has a taxable win of approximately \$23.0 million in future years, under the bill BetMGM retains \$16.0 million, \$3.5 million is distributed to BMFF as required under current law, and \$3.5 million is distributed as local impact grants.

Appendix - Maryland Gaming

The State of Maryland has authorized and awarded six video lottery operation licenses in Baltimore City and Allegany, Anne Arundel, Cecil, Prince George's, and Worcester counties with a maximum number of 16,500 video lottery terminals (VLTs) allotted in the State. The opening date and the number of VLTs and table games in operation for each facility as of December 2023 are shown in **Exhibit 1**.

Video Lottery Terminals and Table Game Revenues

The estimated revenues from VLTs and table games in fiscal 2025 through 2029 are shown in **Exhibit 2**. A total of \$2.0 billion in gross gaming revenues is projected in fiscal 2025, including \$596.7 million to be distributed to the Education Trust Fund.

Chapter 492 of 2020, a constitutional amendment approved by the voters at the November 2020 general election, authorized sports and event wagering, contingent upon implementation legislation passed by the General Assembly. Chapter 356 of 2021 implemented sports wagering in the State and provides for regulation of sports wagering and fantasy gaming competitions. Licensees receive 85% of proceeds from sports wagering and fantasy gaming and the State receives 15%, as well as license fee revenues. State revenues from sports wagering and fantasy gaming and their distributions are shown in **Exhibit 3**.
