Natural Resources - Sale, Barter, or Exchange of Mounted Specimens From  
Decedent's Estate

---

This departmental bill establishes an exception to the existing prohibition against selling, offering for sale, bartering, or exchanging any game bird or mammal taken from the wild. Under the bill, the prohibition does not apply to a legally acquired mounted specimen of a game bird, excluding a migratory game bird, or game mammal, if the original owner is deceased and the specimen is part of the personal property of an owner whose estate is being liquidated or distributed.

Fiscal Summary

**State Effect:** The bill is not expected to materially affect State finances.

**Local Effect:** None.

**Small Business Effect:** The Department of Natural Resources (DNR) has determined that this bill has minimal or no impact on small business (attached). The Department of Legislative Services concurs with this assessment.

Analysis

**Current Law:**

*Prohibition against Selling Game Birds or Mammals*

Generally, a person may not sell, offer for sale, barter, or exchange, at any time within the State, any game bird or mammal taken from the wild in the State or in another state,

territory, or country. However, the prohibition does not apply to the legally acquired (1) meat, pelt, carcass, or mounted specimen of any beaver, coyote, fisher, fox, mink, muskrat, nutria, opossum, otter, raccoon, skunk, or long-tailed weasel; (2) hide, hair, tail, or feet of deer, squirrel, or rabbit (excluding a mounted specimen); (3) feathers, skin, or feet of upland and forest game birds (excluding a mounted specimen); (4) unless prohibited by federal law, feathers of wetland game birds; or (5) antlers of deer legally acquired in another state and manufactured into an article of commerce in another state.

Title 10 of the Natural Resources Article defines “game birds or mammals” as the species defined as forest game birds and mammals, fur-bearing mammals, upland game birds and mammals, and wetland games birds or any part, egg, offspring, or dead body of any of them. “Migratory game bird” means any wetland game bird, dove, or woodcock or any part, egg, offspring, or dead body of any of them.

#### *Property of a Deceased Person*

Under the Estates and Trusts Article, all property of a decedent (deceased person) is subject to the estates of decedents law, and upon the person’s death must pass directly to the personal representative (a fiduciary who settles and distributes the estate of the decedent in accordance with the terms of any will and the estates of decedents law) for administration and distribution. “Property” is all real and personal property of the decedent and any right or interest in the property, which does not pass, at the time of the decedent’s death, to another person by the terms of the instrument under which it is held, or by operation of law.

#### *Personal Representative’s Power to Liquidate and/or Distribute the Estate*

The personal representative has various statutory powers to administer the property of a decedent’s estate, including the power to sell property and distribute the cash proceeds to the heirs (persons who are entitled to property of a decedent that is not distributed by will) or legatees (persons who receive property under the terms of a will). Also, the personal representative may, subject to the terms of the will and the needs of administration, distribute property (including personal property) of an estate in kind, instead of in cash, to the heirs or legatees.

**Background:** DNR advises that mounted specimens associated with an estate currently can only be donated or disposed of and few places exist that will take them as a donation. According to DNR, the intent of the statute is to prohibit monetizing wildlife, to protect against poaching and exploitation; however, the department does not view the sale of mounted specimens under the bill’s exception as a major risk to the resource.
