AMENDMENT NO. 1

On page 1, in line 2, strike "Title"; in the same line, strike "Acting as Limited Liability Companies"; in lines 3 and 9, in each instance, strike "title"; and in line 6, after "qualification" insert "<u>for a title insurance agent</u>".

AMENDMENT NO. 2

On page 2, in line 11, after "PARTNERSHIP," insert "<u>EACH INDIVIDUAL WHO HAS</u> <u>DIRECT CONTROL OVER ITS FISCAL MANAGEMENT,</u>"; in the same line, strike "OR"; and in the same line, after "MEMBER" insert "<u>, OR MANAGER</u>".

On page 2 in line 24 and on page 4 in line 23, in each instance, strike "THE" and substitute "EACH".

On page 2 in line 29 and on page 4 in line 28, in each instance, after "COMPANY," insert "EACH INDIVIDUAL WHO HAS DIRECT CONTROL OVER ITS FISCAL MANAGEMENT AND".

On page 2 in line 29, on page 3 in line 29, and on page 4 in line 28, in each instance, after "MEMBER," insert "<u>MANAGER</u>,".

On page 2, in line 38, strike "\$ 429(C)" and substitute "\$ 492(C)"; and in the same line, after "AND" insert "<u>EACH</u>".

On page 3 in line 3 and on page 4 in line 40, in each instance, after "OF" insert "<u>EACH</u> <u>INDIVIDUAL WHO HAS DIRECT CONTROL OVER ITS FISCAL MANAGEMENT AND</u>".

On page 3 in line 3 and on page 4 in line 40, in each instance, strike "AND EACH

(Over)

OFFICER" and substitute ", MANAGER, OFFICER,".

On page 3 in line 28 and on page 5 in line 34, in each instance, before "an" insert "<u>AN</u> <u>INDIVIDUAL WHO HAS DIRECT CONTROL OVER ITS FISCAL MANAGEMENT OR</u>".

On page 4, in line 10, after "CORPORATION," insert "<u>EACH INDIVIDUAL WHO HAS</u> <u>DIRECT CONTROL OVER ITS FISCAL MANAGEMENT</u>,"; in line 11, after "owner" insert ", <u>MEMBER, OR MANAGER</u>"; and in line 37, after the first "of" insert "<u>EACH CONTROLLING</u> <u>OWNER AND</u>".

On page 5, in line 34, strike the first "or"; in the same line, after "partner" insert "<u>MEMBER, MANAGER, OWNER, OR EMPLOYEE</u>"; in the same line, after "the" insert "<u>LIMITED LIABILITY COMPANY</u>,"; and in the same line, after "partnership" insert a comma.

AMENDMENT NO. 3

On page 3 in line 28 and on page 5 in lines 33 and 34 strike "for any violation of this subtitle by" and substitute "<u>IF</u>"; and on page 3 in line 31 and on page 5 in line 34, in each instance, after "corporation" insert "<u>HAS</u>:

(1) VIOLATED ANY PROVISION OF THIS SUBTITLE;

(2) BEEN CONVICTED OF A FELONY, A CRIME OF MORAL TURPITUDE, OR ANY CRIMINAL OFFENSE INVOLVING DISHONESTY OR BREACH OF TRUST; OR

(3) HAD ANY PROFESSIONAL LICENSE SUSPENDED OR REVOKED FOR A FRAUDULENT OR DISHONEST PRACTICE".
