# 1. AN AGENCY OF THE STATE GOVERNMENT OR OF A POLITICAL SUBDIVISION OF THE STATE EXCEPT: A. AN AMBULANCE, FIRE FIGHTING, OR RESCUE SQUAD;

#### <u>OR</u>

## B. A PRIMARY SCHOOL, SECONDARY SCHOOL, OR

#### COLLEGE;

# 2. A LAW ENFORCEMENT AGENCY OR LAW ENFORCEMENT FRATERNAL ORGANIZATION; OR

## 3. A POLITICAL CLUB, COMMITTEE, OR PARTY.".

On page 6, in line 13, strike "DISTRIBUTE" and substitute "<u>WHOLESALE FOR PROFIT</u>"; in line 15, strike "Has" and substitute

"(I) OTHER THAN A VOLUNTEER FIRE COMPANY OR VOLUNTEER RESCUE COMPANY, HAS";

in line 16, strike "1 YEAR" and substitute "3 YEARS"; and in line 17, after "RETURN;" insert "OR

# (II) IN THE CASE OF A VOLUNTEER FIRE COMPANY OR VOLUNTEER RESCUE COMPANY, HAS BEEN ESTABLISHED IN THE COUNTY FOR AT LEAST 1 YEAR;".
