AMENDMENTS TO SENATE BILL NO. 531, AS AMENDED

(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, in lines 2 and 21, in each instance, strike “Nurse Aides” and substitute “Nursing Assistants”; in lines 3, 4, and 8, in each instance, strike “nurse aide” and substitute “nursing assistant”; and in lines 8 and 11, in each instance, strike “nurse aides” and substitute “nursing assistants”.

AMENDMENT NO. 2

On page 1 of the Economic and Environmental Affairs Committee Amendments (SB0531/193794/1), in line 2 of Amendment No. 2, strike “nurse aide” and substitute “nursing assistant”; and in line 12 of Amendment No. 4, strike “NURSE AIDE” and substitute “NURSING ASSISTANT”.

AMENDMENT NO. 3

On page 2 of the bill, in line 9, strike “NURSE AIDES” and substitute “NURSING ASSISTANTS”; and in lines 15, 19, 20, 21, 22, and 30, in each instance, strike “NURSE AIDE” and substitute “NURSING ASSISTANT”.

On page 3 of the bill, in lines 7, 9, 13, and 26, in each instance, strike “NURSE AIDE” and substitute “NURSING ASSISTANT”; and in lines 16 and 19, in each instance, strike “NURSE AIDES” and substitute “NURSING ASSISTANTS”.

On page 4 of the bill, in lines 7, 20, 29, 32, and 33, on page 5 in lines 1, 8, 14, 15, 17, 21, 25, and 26, on page 6 in line 39, on page 7 in lines 1, 11, 12, 17, and 23, and on page 8 in lines 5, 10, and 26, in each instance, strike “NURSE AIDE” and substitute “NURSING ASSISTANT”.

On page 8 of the bill, in lines 28 and 29 and lines 30 and 31, in each instance, strike “NURSE AIDE” and substitute “NURSING ASSISTANT”.

AMENDMENT NO. 4

On page 3 of the bill, in line 2, strike “OR”; and in line 5, after “PRECEPTORS” insert “;OR

(5) IS SPECIFICALLY TRAINED TO PERFORM SELECTED NURSING FUNCTIONS IN A FACILITY LICENSED BY THE DEVELOPMENTAL DISABILITIES ADMINISTRATION UNDER TITLE 7 OF THE HEALTH - GENERAL ARTICLE OR A COMMUNITY MENTAL HEALTH PROGRAM APPROVED BY THE DEPARTMENT UNDER TITLE 10 OF THE HEALTH - GENERAL ARTICLE, WHILE UNDER THE SUPERVISION OF A REGISTERED NURSE OR LICENSED PRACTICAL NURSE AND IN ACCORDANCE WITH REGULATIONS ADOPTED BY THE BOARD”.
