# AMENDMENTS TO HOUSE BILL NO. 1442

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 4, strike "a Public Defender System Advisory Board" and substitute "<u>a</u> certain number of Public Defender Regional Advisory Boards".

# AMENDMENT NO. 2

On page 3, in line 16, strike "one Public Defender System Advisory Board" and substitute "four Public Defender Regional Advisory Boards".

# AMENDMENT NO. 3

On page 4, strike in their entirety lines 29 through 39, inclusive.

On page 5, strike in their entirety lines 1 through 6, inclusive, and substitute:

- "(A) IN THIS SECTION, "BOARD" MEANS A PUBLIC DEFENDER REGIONAL ADVISORY BOARD.
  - (B) (1) THERE ARE FOUR PUBLIC DEFENDER REGIONAL ADVISORY BOARDS.
- (2) EACH BOARD SHALL BE COMPOSED OF FIVE MEMBERS, OF WHICH THREE SHALL CONSTITUTE A QUORUM FOR ALL BUSINESS.
- (3) THE FIRST BOARD SHALL ADVISE PUBLIC DEFENDER DISTRICTS ONE, EIGHT, AND NINE, WHICH ENCOMPASS BALTIMORE CITY, BALTIMORE COUNTY, AND HARFORD COUNTY.
- (4) THE SECOND BOARD SHALL ADVISE PUBLIC DEFENDER DISTRICTS
  TWO AND THREE, WHICH ENCOMPASS DORCHESTER, WICOMICO, SOMERSET,

#### WORCESTER, CAROLINE, TALBOT, OUEEN ANNE'S, KENT, AND CECIL COUNTIES.

- (5) THE THIRD BOARD SHALL ADVISE PUBLIC DEFENDER DISTRICTS FOUR, FIVE, AND SEVEN, WHICH ENCOMPASS CHARLES, ST. MARY'S, CALVERT, PRINCE GEORGE'S, AND ANNE ARUNDEL COUNTIES.
- (6) THE FOURTH BOARD SHALL ADVISE PUBLIC DEFENDER DISTRICTS SIX, TEN, ELEVEN, AND TWELVE, WHICH ENCOMPASS MONTGOMERY, HOWARD, CARROLL, FREDERICK, WASHINGTON, ALLEGANY, AND GARRETT COUNTIES.
- (7) EACH MEMBER SHALL BE A JUDGE OF THE CIRCUIT COURT, A JUDGE OF THE DISTRICT COURT, OR AN ACTIVE ATTORNEY AT LAW ADMITTED TO PRACTICE BEFORE THE COURT OF APPEALS OF MARYLAND.
- (8) A MEMBER OF A BOARD SHALL BE A RESIDENT OF A DISTRICT REPRESENTED BY THAT BOARD AND SHALL BE APPOINTED BY THE GOVERNOR FOR A TERM OF 3 YEARS.
- (9) ANY VACANCY OCCURRING ON A BOARD DURING THE TERM OF ANY MEMBER SHALL BE FILLED BY THE GOVERNOR FOR THE REMAINDER OF THE UNEXPIRED TERM.
- (10) THE GOVERNOR SHALL ANNUALLY DESIGNATE A CHAIRMAN OF EACH BOARD, WHO SHALL PRESIDE OVER AND REPRESENT THE INTERESTS OF THAT BOARD IN CARRYING OUT THE PROVISIONS OF THIS ARTICLE.".

#### AMENDMENT NO. 4

On page 5, in line 7, strike "THE" and substitute "<u>EACH</u>"; and in line 10, after "defender" insert "FROM A DISTRICT REPRESENTED BY THAT BOARD,".

# AMENDMENT NO. 5

On page 5, in line 11, strike "The"; in the same line, after "boards]" insert "<u>EACH</u>"; in line 12, strike "office" and substitute "<u>OFFICES</u>"; in line 13, strike "defender" and substitute "<u>DEFENDERS</u>"; and in line 14, strike the second "the" and substitute "<u>EACH</u>".

### AMENDMENT NO. 6

On page 5, in line 16, strike "THE" and substitute "EACH".
