## AMENDMENTS TO HOUSE BILL NO. 273 (First Reading File Bill)

#### AMENDMENT NO. 1

On page 1, strike beginning with "specifying" in line 4 down through "recover" in line 5 and substitute "<u>allowing certain damages to be awarded</u>"; and in line 7, after "order;" insert "<u>altering certain definitions;</u>".

#### AMENDMENT NO. 2

On page 1, in line 24, strike "(I)". On pages 1 and 2, strike beginning with the first "A" in line 24 on page 1 through "AREA" in line 7 on page 2 and substitute: "<u>:</u>

## (I) ANY AREA INSIDE A PRIVATE RESIDENCE; OR

## (II) A DRESSING ROOM, BEDROOM, OR REST ROOM IN:

## 1. AN OFFICE, BUSINESS, OR STORE;

## 2. A RECREATIONAL FACILITY;

## 3. A RESTAURANT OR TAVERN;

## 4. A HOTEL, MOTEL, OR OTHER LODGING FACILITY;

## 5. A THEATER OR SPORTS ARENA; OR

## 6. ANOTHER PLACE OF PUBLIC USE OR ACCOMMODATION".

#### AMENDMENT NO. 3

On page 2, in line 8, after "(3)" insert "(I)"; in the same line, after "means" insert "DELIBERATE, SURREPTITIOUS OBSERVATION OF ANOTHER BY ANY MEANS

<u>INCLUDING</u>"; in lines 9, 10, 11, and 12, strike "(i)", "(ii)", "(iii)", and "(iv)", respectively, and substitute "<u>1</u>.", "<u>2</u>.", "<u>3</u>.", and "<u>4</u>.", respectively; and after line 13, insert:

# "(II) "VISUAL SURVEILLANCE" DOES NOT INCLUDE A CASUAL, MOMENTARY, OR UNINTENTIONAL OBSERVATION OF ANOTHER.".

#### AMENDMENT NO. 4

On page 2, in line 17, after "(c)" insert "(<u>1</u>)"; and after line 18, insert:

# "(2) A GOOD FAITH RELIANCE ON A COURT ORDER IS A COMPLETE DEFENSE TO ANY CIVIL OR CRIMINAL ACTION BROUGHT UNDER THIS SECTION.".

#### AMENDMENT NO. 5

On page 2, in line 22, strike "(1)"; in lines 24 and 25, in each instance, strike the bracket; in line 24, strike "actual"; and strike beginning with "AND" in line 25 down through the period in line 34.

## AMENDMENT NO. 6

On page 2, in line 35, strike "any" and substitute "<u>: (1) ANY</u>"; and in line 36, after "duties" insert "<u>: OR</u>

(2) VISUAL SURVEILLANCE, BY OR WITH THE CONSENT OF ANY RESIDENT OF A PRIVATE RESIDENCE".
