AMENDMENT NO. 4

On page 2, in line 27, after "purpose" strike the comma; and in the same line, after "and" insert "MAY INCLUDE GRANT FUNDS RECEIVED FROM THE MAYOR AND CITY COUNCIL OF BALTIMORE OR FUNDS RECEIVED FROM PRIVATE SOURCES, ALL OF WHICH THE GRANTEE HAS EXPENDED FOR USES PERMITTED UNDER THIS ACT OR FOR OTHER COSTS AND EXPENSES INCURRED BY THE GRANTEE IN THE PLANNING, DESIGN, CONSTRUCTION, ALTERATION, RENOVATION, FURNISHING, AND EQUIPPING OF THE CHILDREN'S MUSEUM AND IN THE PLANNING, DESIGN, ACQUISITION, FABRICATION, AND INSTALLATION OF EXHIBITS TO BE DISPLAYED IN

THE MATCHING FUND MAY INCLUDE GRANT FUNDS RECEIVED FROM THE MAYOR AND CITY COUNCIL OF BALTIMORE OR FUNDS RECEIVED FROM PRIVATE SOURCES, ALL OF WHICH THE GRANTEE HAS EXPENDED FOR USES PERMITTED UNDER THIS ACT OR FOR OTHER COSTS AND EXPENSES INCURRED BY THE GRANTEE IN THE PLANNING, DESIGN, CONSTRUCTION, ALTERATION, RENOVATION, FURNISHING, AND EQUIPPING OF THE CHILDREN'S MUSEUM AND IN THE PLANNING, DESIGN, ACQUISITION, FABRICATION, AND INSTALLATION OF EXHIBITS TO BE DISPLAYED IN THE CHILDREN'S MUSEUM."

AMENDMENT NO. 8

On page 4, in line 10, strike "(A)"; in the same line strike "(II)" and substitute "(II)"; strike beginning with "AND" in line 13 down through "FURNISHINGS" in line 14 and substitute "ALTERATION, RENOVATION, EQUIPPING, AND FURNISHING, AS PERMITTED IN THIS ACT "; and strike in their entirety lines 15 through 18, inclusive.
