AMENDMENT NO. 1

On page 1, in line 6, strike "authorizing" and substitute "<u>requiring</u>"; and strike beginning with "regulations" in line 6 down through "for" in line 7 and substitute "<u>certain regulations, and perform certain acts, effective by a certain date, concerning</u>".

AMENDMENT NO. 2

On page 4, in line 20, strike "LOOKS" and substitute "<u>BOOKS</u>"; in the same line, strike "TIP JARS,"; and in lines 29 and 30, strike "SUBSECTIONS (C)(1) THROUGH (C)(5)" and substitute "<u>SUBSECTION (C)(1)</u>".

AMENDMENT NO. 3

On page 5, in line 1, after "(C)" insert "<u>(1)</u>"; in lines 5, 8, 11, and 13, strike "(1)", "(2)", "(3)", and "(4)", respectively, and substitute "<u>(1)</u>", "<u>(II)</u>", "<u>(III)</u>", and "<u>(IV)</u>", respectively; in line 11, after "ORGANIZATION" insert "<u>THAT IS EXEMPT FROM TAXATION UNDER § 501(C)(3) OF</u> <u>THE INTERNAL REVENUE CODE AND</u>"; in line 12, after "COUNTY" insert "<u>FOR A PERIOD</u> <u>OF AT LEAST 3 YEARS</u>"; and in line 14, strike "DESIRING" and substitute "<u>THAT IS EXEMPT</u> <u>FROM TAXATION UNDER § 501(C)(3), (4), OR (10) OF THE INTERNAL REVENUE CODE</u> <u>AND DESIRES</u>".

AMENDMENT NO. 4

On page 5, in line 15, strike "CHARITY" and substitute "<u>BONA FIDE CHARITABLE</u> <u>ORGANIZATION</u>"; and strike in their entirety lines 16 through 18, inclusive, and substitute:

"(V) A BONA FIDE NONPROFIT ORGANIZATION THAT DESIRES TO RAISE MONEY FOR AN EXCLUSIVELY CHARITABLE, ATHLETIC, OR EDUCATIONAL PURPOSE AND HAS BEEN OPERATING ON A NONPROFIT BASIS IN KENT COUNTY FOR A PERIOD OF AT LEAST 3 YEARS.

(2) TO QUALIFY UNDER ITEM (1)(V) OF THIS SUBSECTION OR SUBSECTION (H) OF THIS SECTION, THE CHARITABLE, ATHLETIC, OR EDUCATIONAL PURPOSE:

(I) SHALL MEET THE REQUIREMENTS FOR A CHARITABLE CONTRIBUTION UNDER § 170(C) OF THE INTERNAL REVENUE CODE; AND

(II) MAY NOT BE A PURPOSE TO BENEFIT:

<u>1. AN AGENCY OF THE STATE GOVERNMENT OR A</u> POLITICAL SUBDIVISION OF THE STATE, EXCEPT:

A. AN AMBULANCE, FIRE FIGHTING, OR RESCUE SQUAD;

<u>OR</u>

B. A PRIMARY SCHOOL, SECONDARY SCHOOL, OR

COLLEGE;

2. A LAW ENFORCEMENT AGENCY OR LAW ENFORCEMENT FRATERNAL ORGANIZATION; OR

3. A POLITICAL CLUB, COMMITTEE, OR PARTY.".

AMENDMENT NO. 5

On page 5, in line 19, strike "(1)"; and strike in their entirety lines 21 through 23, inclusive.

AMENDMENT NO. 6

On page 5, in line 24, strike "MAY" and substitute "<u>SHALL, EFFECTIVE NOT LATER</u> <u>THAN JULY 1, 1997</u>".

AMENDMENT NO. 7

On page 6, in line 5, after "SUBSECTION (C)" insert "<u>OF THIS SECTION</u>"; and in line 10, after "FOR" insert "<u>A</u>".
