# AMENDMENT NO. 1

On page 1, in line 5, after "dishonor;" insert "providing that a suspension is effective only under certain circumstances and after a certain time period;"; and in line 6, strike "licensee" and substitute "applicant for license issuance or renewal".

#### AMENDMENT NO. 2

On page 2, in lines 6 and 7, strike "FROM THE DATE THE LICENSE WAS ISSUED OR RENEWED" and substitute ". EXCEPT AS PROVIDED IN SUBSECTIONS (B) AND (C) OF THIS SECTION, THE SUSPENSION IS EFFECTIVE BEGINNING ON THE TENTH BUSINESS DAY AFTER THE DAY ON WHICH NOTICE IS SENT IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION"; in line 10, after "(B)" insert "(1)"; in line 14, strike "HAS BEEN" and substitute "WILL BE"; in line 15, strike the period and substitute "IF WITHIN 10 BUSINESS DAYS FROM THE DATE OF THE NOTICE THE APPLICANT FAILS TO MAKE PAYMENT OF THE FEE, AND ANY LATE CHARGE, OR FAILS TO PRESENT EVIDENCE TO THE DEPARTMENT OR UNIT THAT THE NOTICE OF DISHONOR WAS IN ERROR.

strike beginning with "IF" in line 19 down through "RENEWED" in line 23 and substitute "<u>IF A LICENSE IS SUSPENDED UNDER SUBSECTION (A) OF THIS SECTION, THE LICENSE SHALL BE REINSTATED EFFECTIVE THE DATE THAT THE LICENSE WAS SUSPENDED, IF WITHIN 5 BUSINESS DAYS AFTER THE DATE OF THE SUSPENSION THE APPLICANT:</u>

# (I) PAYS THE LATE FEE AND ANY LATE CHARGE; OR

(II) PRESENTS EVIDENCE TO THE DEPARTMENT OR THE UNIT THAT THE NOTICE OF DISHONOR WAS IN ERROR";

in lines 33 and 34, strike "FROM THE DATE THE LICENSE WAS ISSUED OR RENEWED" and substitute ". EXCEPT AS PROVIDED IN SUBSECTIONS (B) AND (C) OF THIS SECTION, THE SUSPENSION IS EFFECTIVE BEGINNING ON THE TENTH BUSINESS DAY AFTER THE DAY ON WHICH THE NOTICE IS SENT IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION"; in line 24, strike "SHALL" and substitute "MAY"; in line 37, after "(B)" insert "(1)"; in line 41, strike "HAS BEEN" and substitute "WILL BE"; and in line 42, strike the period and substitute "IF WITHIN 10 BUSINESS DAYS AFTER THE DATE OF THE NOTICE THE APPLICANT FAILS TO MAKE PAYMENT OF THE FEE, AND ANY LATE CHARGE, OR FAILS TO PRESENT EVIDENCE TO THE DEPARTMENT OR UNIT THAT THE NOTICE OF DISHONOR WAS IN ERROR.

On page 3, strike beginning with "IF" in line 3 down through "RENEWED" in line 7 and substitute "IF A LICENSE IS SUSPENDED UNDER SUBSECTION (A) OF THIS SECTION, THE LICENSE SHALL BE REINSTATED EFFECTIVE THE DATE THE LICENSE WAS SUSPENDED IF WITHIN 5 BUSINESS DAYS FROM THE DATE OF THE SUSPENSION THE APPLICANT:

#### (I) PAYS THE FEE AND LATE CHARGE; OR

(II) PRESENTS EVIDENCE TO THE DEPARTMENT OR THE UNIT THAT THE NOTICE OF DISHONOR WAS IN ERROR";

and in line 8, strike "SHALL" and substitute "MAY".
