Full reimbursement shall apply to companies that exceed the out-of-state limit within two years of graduation from the incubator, 75 percent if within three years, 60 percent if within four years, and 25 percent if within five years. Provided, however, that for each year that an incubator graduate adds at least ten full-time Maryland resident employees, it shall offset for one year of subsidy repayment or increase in equity held by the University. The State of Maryland is vitally interested in attracting and retaining new businesses through a number of innovative programs such as incubator subsidies. It is not our wish to penalize but to provide incentive to companies to remain in Maryland.".

- (2) the budget committees have reviewed and commented on the report or 45 days have elapsed from the date the report is received by the committees".
