On page 1, in line 2, before "Bowie" insert "<u>Higher Education -</u>"; in lines 2, 3, 11, and 14, in each instance, before "Violence" insert "<u>Alternative Dispute Resolution and</u>"; in line 3, strike "creating" and substitute "<u>recognizing</u>"; in line 6, after "program" insert "<u>, implement violence</u> prevention networks, provide certain information and training, academic support, and other services regarding violence prevention education, and provide certain educational and academic support regarding violence prevention"; in the same line, after "encouraging" insert "<u>individuals and groups</u> operating"; and in line 10, strike "creation" and substitute "<u>recognition</u>".

AMENDMENT NO. 2

On page 1, in lines 21 and 27, in each instance, before "VIOLENCE" insert "<u>ALTERNATIVE DISPUTE RESOLUTION AND</u>"; in line 24, strike "THAT OFFERS" and substitute "<u>IN WHICH</u>"; and in the same line, after "TRAINING" insert "<u>IS OFFERED</u>".

On page 2, in lines 4 and 14, in each instance, after "STATE" insert "<u>OR AVAILABLE TO</u> <u>THE STATE</u>"; strike beginning with "AND" in line 4 down through "PUBLIC" in line 6 and substitute:
