1 AN ACT concerning

2 Education - School System Performance Audit

- 3 FOR the purpose of requiring the Maryland State Department of Educationto contract
- 4 for a performance audit of a county school system at the request of the county
- 5 governing body under certain circumstances; defining a certain term;providing that
- 6 the cost of the performance audit shall be shared equally between the county
- 7 governing body and the county school board; and generally relating to performance
- 8 audits of county school systems.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

- 18 (A) IN THIS SECTION, "PERFORMANCE AUDIT" MEANS AN ASSESSMENT OF AN
- 19 ENTITY'S OR PROGRAM'S PRACTICES TO DETERMINE WHETHER THE ENTITY OR
- 20 PROGRAM IS OPERATING ECONOMICALLY AND EFFICIENTLY AND WHETHER
- 21 CORRECTIVE ACTIONS FOR IMPROVING ITS PERFORMANCE ARE APPROPRIATE.
- 22 (B) IN THE ABSENCE OF AN AGREEMENT BETWEEN A COUNTY GOVERNING
- 23 BODY AND A COUNTY SCHOOL BOARD, THE DEPARTMENT AT THE REQUEST OF THE
- 24 COUNTY GOVERNING BODY SHALL CONTRACT FOR A PERFORMANCE AUDIT OF THE
- 25 COUNTY PUBLIC SCHOOL SYSTEM TO ADDRESS THE ISSUES RAISED IN THE
- 26 COUNTY'S REQUEST.
- 27 (C) THE DEPARTMENT SHALL MAKE REASONABLE EFFORTS TO ENSURE
- 28 THAT A PERFORMANCE AUDIT UNDER THIS SECTION IS COMPLETED AND THE
- 29 RESULTS OF THE AUDIT ARE MADE AVAILABLE TO THE COUNTY BOARD IN TIME TO

- $1\,$ BE CONSIDERED BY THE COUNTY BOARD IN THE PREPARATION OF ITS BUDGET FOR $2\,$ THE NEXT FISCAL YEAR.
- 3 (D) THE COST OF A PERFORMANCE AUDIT UNDER THIS SECTION SHALL BE
- 4 SHARED EQUALLY BETWEEN THE COUNTY GOVERNING BODY AND THE COUNTY
- 5 BOARD.
- 6 (E) A PERFORMANCE AUDIT UNDER THIS SECTION:
- 7 (1) SHALL BE CONDUCTED IN ACCORDANCE WITH GENERALLY
- 8 ACCEPTED GOVERNMENT AUDITING STANDARDS; AND
- 9 (2) MAY NOT INCLUDE AN ASSESSMENT OR EVALUATION OF A COUNTY
- 10 BOARD'S EFFORTS TO MEET THE STANDARDS OF THE MARYLAND SCHOOL
- 11 PERFORMANCE PROGRAM.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 July 1, 1996.
