1 AN ACT concerning

2 Health Insurance - Reconstructive Breast Surgery - Coverage

3 FOR the purpose of requiring that certain insurers, nonprofit health service plans, and

- 4 health maintenance organizations provide coverage for certain reconstructive breast
- 5 surgery; defining a certain term; providing for the application of this Act; and
- 6 generally relating to the provision of coverage for certain reconstructive breast
- 7 surgery.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

19 MARYLAND, That the Laws of Maryland read as follows:

1 Article 48A - Insurance Code

2 490FF.

3 (A) (1) IN THIS SECTION, "RECONSTRUCTIVE BREAST SURGERY" MEANS
4 SURGERY PERFORMED, FOLLOWING A MASTECTOMY, ON ONE BREAST OR BOTH
5 BREASTS TO REESTABLISH SYMMETRY BETWEEN THE TWO BREASTS.

6 (2) "RECONSTRUCTIVE BREAST SURGERY" INCLUDES AUGMENTATION 7 MAMMOPLASTY, REDUCTION MAMMOPLASTY, AND MASTOPEXY.

8 (B) AN INSURER OR NONPROFIT HEALTH SERVICE PLAN THAT PROVIDES
9 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS FOR ISSUANCE OR DELIVERY IN THE
10 STATE TO ANY GROUP OR INDIVIDUAL ON AN EXPENSE-INCURRED BASIS,
11 INCLUDING A HEALTH MAINTENANCE ORGANIZATION, SHALL PROVIDE COVERAGE
12 FOR RECONSTRUCTIVE BREAST SURGERY.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all

20 new policies or health benefit plans issued or delivered in the State on or after the

21 effective date of this Act and to the renewal of all policies in effectbefore that date,

22 except that any policy or health benefit plan in effect before October 1, 1996 shall comply

23 with the provisions of this Act no later than October 1, 1997.

24 SECTION 2. <u>3.</u> AND BE IT FURTHER ENACTED, That this Act shall take effect 25 October 1, 1996.
