10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

11 MARYLAND, That the Laws of Maryland read as follows:

12 Article 27 - Crimes and Punishments

14 (b) Any person who (1) intentionally mutilates or cruelly kills an animal, or

15 causes, procures, or authorizes the cruel killing or intentional mutilation of an animal;

16 [or] (2) uses or permits a dog to be used in A DOGFIGHT; or (3) arranges [or], conducts,

17 OR ATTENDS a dogfight, is guilty of a misdemeanor punishable by a fine not exceeding

18 \$5,000 or by imprisonment not to exceed 3 years, or both.

- 19 (a) Any person who (1) overdrives, overloads, deprives of necessary sustenance,
- 20 tortures, torments, or cruelly beats; or (2) causes, procures or authorizes these acts; or (3)
- 21 having the charge or custody of an animal, either as owner or otherwise, inflicts
- 22 <u>unnecessary suffering or pain upon the animal, or unnecessarily fails to provide the</u>
- 23 animal with nutritious food in sufficient quantity, necessary veterinary care, proper drink,
- 24 <u>air, space, shelter or protection from the weather; or (4) uses or permits to be used any</u>

- 1 bird, fowl, or cock for the purpose of fighting with any other animal, which is commonly
- 2 known as cockfighting[,]; OR (5) KNOWINGLY ATTENDS A DELIBERATELY
- 3 CONDUCTED DOGFIGHT AS A SPECTATOR, is guilty of a misdemeanor punishable by a
- 4 fine not exceeding \$1,000 or by imprisonment not to exceed 90 days, or both.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 6 October 1, 1996.
