A BILL ENTITLED

1 AN ACT concerning

2 Board of Public Works - Northern Central Railway Company

- 3 FOR the purpose of repealing certain authority of the Board of Public Works to sell and
- 4 effect the transfer of a certain annuity of the Northern Central Railway Company;
- 5 repealing certain authority of the Board of Public Works to release certain lands
- from the lien of a certain mortgage from the Northern Central Railway Company to
- 7 the State; and generally relating to certain authority of the Board of Public Works
- 8 concerning the Northern Central Railway Company.

9 BY repealing

- 11 Section 12, 13, and 13A

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 MARYLAND, That the Laws of Maryland read as follows:

16 Article 78A - Public Works

17 [12.

- 18 The Board of Public Works is authorized, in the discretion of said Board, to call for
- 19 sealed bids and to sell to the highest bidder for cash and to transfer to the purchaser or
- 20 purchasers thereof the annuity of ninety thousand dollars created by virtue or in
- 21 pursuance of the provisions of Chapter 260 of the Acts of the General Assembly of
- 22 Maryland, passed at the January session of 1854, and which said annuityis payable by the
- 23 Northern Central Railway Company to the State of Maryland; provided, said Board of
- 24 Public Works shall not sell and transfer the same for any smaller or less sum of money
- 25 than a sum equal to the capitalization of said annuity at the rate of four per centum,
- 26 together with the amounts of such quarterly payments as may then be dueand unpaid,
- 27 and interest thereon, and the proportionate part of the accruing quarterly payment,
- 28 calculated to the date of such transfer; and provided further, that said Board of Public
- 29 Works may accept in payment or in part payment of the purchase price ofsaid annuity,
- 30 the bonds of or registered debt owing by the State at the market value thereof, or cash, in
- 31 its discretion; and such purchaser or purchasers, its and their successor, successors or
- 32 assigns (if such purchaser or purchasers be a body corporate or bodies corporate), or his,

- 1 her or their executors, administrators or assigns (if such purchaser orpurchasers be a
- 2 natural person or persons), shall, upon such transfer of and payment for said annuity,
- 3 succeed to and have all and every, the rights, incidents, interests andestate now held or
- 4 owned by the State of Maryland in said annuity and in the mortgage security thereof; and
- 5 all money received from the sale of said annuity shall be credited to the annuity bond
- 6 account and applied by the Treasurer to the payment of the State debt.]

- 8 The said Board of Public Works is authorized and empowered to do andperform
- 9 any and all acts, matters and things, and to execute and deliver any and all contracts,
- 10 deeds or paper writings whatsoever, in order to effectually transfer, assign and convey
- 11 said annuity and the mortgage security therefor, together with all and every, the rights,
- 12 incidents, interests and estate of the State of Maryland therein, unto the purchaser or
- 13 purchasers thereof, and generally to do any and all acts, matters and things whatsoever to
- 14 carry out and effectuate the purposes of § 12.]

15 [13A.

- The Board of Public Works is authorized and hereby directed to execute on behalf
- 17 of the State of Maryland, and to deliver to the Northern Central Railway Company from
- 18 time to time a release or releases from the lien of the mortgage, datedJanuary 27, 1855,
- 19 from the Northern Central Railway Company to the State of Maryland, which was
- 20 executed and delivered by virtue or in pursuance of the provisions of Chapter 260 of the
- 21 Acts of the General Assembly of Maryland, passed at the January session of 1854, of such
- 22 lands or interests in lands included within the lien of said mortgage as are no longer
- 23 necessary or expedient to retain for use in the operation of the railroad mortgaged
- 24 thereunder: Provided (1) that any such lands or interests in lands to be released shall
- 25 have been sold or contracted to be sold, (2) that no such lands or interests in lands shall
- 26 be released if thereby the continuity or operation of the lines of the railroad so mortgaged
- 27 shall be broken or substantially impaired, (3) that at the time of execution and delivery of
- 28 such release or releases the Northern Central Railway Company shall notbe in default in
- 29 any of the terms of said mortgage, and (4) that the Northern Central Railway Company
- 30 shall obligate itself in writing to apply the proceeds of any such saleor sales to
- 31 improvement of the remainder of the mortgaged property. The Board of Public Works
- 32 shall accept as sufficient warrant for action hereunder a copy of a resolution of the board
- 33 of directors of the Northern Central Railway Company or of the Pennsylvania Railroad
- 34 Company, lessee of the Northern Central Railway Company, certified by the secretary
- 35 under the seal of the company, stating any facts in this section required to be established
- 36 as a condition of such release or releases, accompanied by a sworn certificate to the like
- 37 effect of the president or a vice-president of the Northern Central Railway Company, or
- 38 of the Pennsylvania Railroad Company, its lessee.]
- 39 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 40 October 1, 1996.
