27 (19), (20), and (21), respectively, of Article 48A - Insurance Code of the Annotated Code
28 of Maryland be renumbered to be Section(s) 41(16), (17), (18), (19), and (20),
29 respectively.

30 SECTION 4. AND BE IT FURTHER ENACTED, That Section(s) 2-112(a)(17),
31 (18), and (19), respectively, of Article - Insurance of the Annotated Code of Maryland
32 (as enacted by Chapter 36 of the Acts of the General Assembly of 1995) be renumbered
33 to be Section(s) 2-112(a)(16), (17), and (18), respectively.

34 SECTION 5. AND BE IT FURTHER ENACTED, That Sections 1 and 3 of this
35 Act shall take effect October 1, 1996.

36 SECTION 6. AND BE IT FURTHER ENACTED, That Sections 2 and 4 of this
37 Act shall take effect October 1, 1997.
