- 16 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 17 INDICATED.
- 18 (2) "HOME OFFICE" MEANS AN OFFICE IN A DWELLING UNIT IF THE
- 19 OFFICE:
- 20 (I) OCCUPIES NO MORE THAN 25% OF THE TOTAL FLOOR AREA OF
- 21 A DWELLING UNIT;
- 22 (II) IS OPERATED BY ONE OR MORE RESIDENTS OF THE DWELLING
- 23 UNIT;
- 24 (III) EMPLOYS NO MORE THAN TWO INDIVIDUALS WHO ARE NOT
- 25 RESIDENTS OF THE DWELLING UNIT; AND
- 26 (IV) INVOLVES ACTIVITY THAT:
