- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:

Article - Business Regulation

- 3 Subject to the evaluation and reestablishment provisions of the Maryland Program
- 4 Evaluation Act, this title and all regulations adopted under this titleshall terminate on
- 5 October 1, [1996] 2002.

6 Article - State Government

- 8 (i) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (E) OF THIS SECTION,
- 9 ON OR BEFORE OCTOBER 1, 2001, AN EVALUATION SHALL BE MADE OF THE
- 10 MARYLAND HOME IMPROVEMENT COMMISSION.
- 11 (J) Except as otherwise provided in subsection (e) of this section, on or before
- 12 July 1, 2004, an evaluation shall be made of the State Board of Dietetic Practice
- 13 established under the Health Occupations Article and the regulations that relate to the
- 14 State Board of Dietetic Practice.
- 15 [(j)] (K) Except as otherwise provided in subsection (e) of this section, on or
- 16 before July 1, 2003, an evaluation shall be made of the State Board of Public Accountancy
- 17 established under the Business Occupations and Professions Article and the regulations
- 18 that relate to the State Board of Public Accountancy.
- 19 [(k)] (L) Except as otherwise provided in subsection (e) of this section, on or
- 20 before July 1, 2004, an evaluation shall be made of the State Board of Acupuncture and
- 21 the regulations that relate to the State Board of Acupuncture.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 23 October 1, 1996.
