2 Education - School Performance Recognition Awards

- 3 FOR the purpose of recognizing a public school's progress on meeting orexceeding
- 4 satisfactory standards established by the State Board of Education under the
- 5 Maryland School Performance Program; providing for distribution of the awards by

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:
- 16 Article Education
- 17 5-203.3.
- 18 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 19 INDICATED.
- 20 (2) "DATA-BASED AREAS" MEANS THOSE AREAS IDENTIFIED BY THE
- 21 STATE BOARD THROUGH THE MARYLAND SCHOOL PERFORMANCE PROGRAM FOR
- 22 WHICH INFORMATION IS TO BE TRACKED FOR EACH SCHOOL, EACH SCHOOL
- 23 SYSTEM, AND THE STATE.
- 24 (3) "MARYLAND SCHOOL PERFORMANCE PROGRAM" MEANS A
- 25 PERFORMANCE BASED EDUCATION ACCOUNTABILITY PROGRAM THAT FOCUSES ON
- 26 ACCOUNTABILITY THROUGH SCHOOL IMPROVEMENT IN THE PUBLIC SCHOOLS.
- 27 (4) "RECIPIENT SCHOOL" MEANS A PUBLIC SCHOOL THAT RECEIVES A
- 28 RECOGNITION AWARD UNDER THIS SECTION.

1 (B) IT IS THE INTENT OF THIS SECTION TO REWARD A SCHOOL'S PROC

- 2 ON MEETING OR EXCEEDING STANDARDS ESTABLISHED BY THE STATE BOARD FOR
- 3 THE DATA-BASED AREAS OF THE MARYLAND SCHOOL PERFORMANCE PROGRAM.
- 4 (C) (1) TO THE EXTENT THAT FUNDS ARE PROVIDED IN THE STATE
- 5 BUDGET, THE STATE SUPERINTENDENT ANNUALLY SHALL DISTRIBUTE
- 6 RECOGNITION AWARDS TO:
- 7 (I) EACH ELEMENTARY, MIDDLE, AND HIGH SCHOOL THAT MEETS
- 8 OR EXCEEDS SATISFACTORY STANDARDS FOR ALL DATA-BASED AREAS OF THE
- 9 MARYLAND SCHOOL PERFORMANCE PROGRAM; AND
- 10 (II) ELEMENTARY AND MIDDLE SCHOOLS THAT SHOW
- 11 SUBSTANTIAL IMPROVEMENT TOWARDS MEETING STANDARDS OF THE MARYLAND
- 12 SCHOOL PERFORMANCE PROGRAM.
- 13 (2) THE STATE SUPERINTENDENT SHALL ESTABLISH GUIDELINES FOR
- 14 DISTRIBUTION OF AWARDS UNDER PARAGRAPH (1)(II) OF THIS SUBSECTION.
- 15 (3) SCHOOLS RECEIVING CHALLENGE GRANT FUNDS AND SCHOOLS IN
- 16 ANY PHASE OF RECONSTITUTION ARE NOT ELIGIBLE FOR RECOGNITION AWARDS.
- 17 (D) (1) THE SCHOOL IMPROVEMENT TEAM OF A RECIPIENT SCHOOL SHALL
- 18 DETERMINE HOW THE AWARD SHALL BE USED SUBJECT TO THE FOLLOWING
- 19 CONDITIONS:
- 20 (I) RECOGNITION FUNDS ARE IN ADDITION TO AND MAY NOT
- 21 SUPPLANT FEDERAL, STATE, AND LOCAL FUNDS REGULARLY APPROPRIATED FOR
- 22 USE BY THE SCHOOL;
- 23 (II) RECOGNITION FUNDS MAY NOT BE USED FOR STAFF BONUSES
- 24 OR DIFFERENTIAL PAY INCREASES; AND
- 25 (III) RECOGNITION FUNDS SHALL BE EXPENDED IN ACCORDANCE
- 26 WITH POLICIES AND PROCEDURES OF THE SCHOOL SYSTEM WHERE THE RECIPIENT
- 27 SCHOOL IS LOCATED.
- 28 (2) THE PRINCIPAL OF A RECIPIENT SCHOOL SHALL FILE WITH THE
- 29 LOCAL SCHOOL SUPERINTENDENT A REPORT INDICATING THE AMOUNT OF THE
- 30 AWARD AND THE USES FOR WHICH IT WAS EXPENDED.
- 31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 32 October 1, 1996.
