## 2 Deer's Head Center and Western Maryland Center Dialysis Fund - Nonlapsing Funds

- 3 FOR the purpose of establishing the Deer's Head Center and Western Maryland Center
- 4 Dialysis Fund as a continuing, nonlapsing special fund for certain purposes;
- 5 providing that the Fund be used exclusively to offset and partially cover the actual
- 6 documented costs of the kidney dialysis services of the Deer's Head Center and
- Western Maryland Center under certain circumstances; providing that certain funds 7
- 8 accrued before a certain date should be paid into the special fund; and generally
- 9 relating to the Deer's Head Center and Western Maryland Center Dialysis Fund.
- 10 BY adding to
- 11 Article - Health - General
- 12 Section 19-503.1
- 13 Annotated Code of Maryland
- 14 (1990 Replacement Volume and 1995 Supplement)
- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15
- 16 MARYLAND, That the Laws of Maryland read as follows:
- Article Health General 17
- 18 19-503.1.
- 19 (A) IN THIS SECTION, "FUND" MEANS THE DEER'S HEAD CENTER AND
- 20 WESTERN MARYLAND CENTER DIALYSIS FUND.
- 21 (B) THERE IS A DEER'S HEAD CENTER AND WESTERN MARYLAND CENTER
- 22 DIALYSIS FUND.
- (C) THE DEPARTMENT SHALL ESTABLISH THE FEES FOR KIDNEY DIALYSIS 23
- 24 SERVICES IN ACCORDANCE WITH § 16-201.
- 25 (D) THE DEPARTMENT SHALL COLLECT THE FEES. AND DEPOSIT THE FEES IN
- 26 AN INTEREST BEARING ACCOUNT UNTIL THE FEES ARE TRANSFERRED INTO THE
- 27 FUND.
- 28 (E) (1) THE FUND IS A CONTINUING, NONLAPSING SPECIAL FUND, NOT
- 29 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

1 (2) THE FUND SHALL BE USED EXCLUSIVELY TO OFFSE
---

- 2 PARTIALLY COVER THE ACTUAL DOCUMENTED COSTS OF THE KIDNEY DIALYSIS
- 3 DISEASE SERVICES OF THE DEER'S HEAD CENTER AND WESTERN MARYLAND
- 4 CENTER DIALYSIS PROGRAMS AS DESCRIBED IN THIS SUBTITLE.
- 5 (3) ANY UNSPENT FUNDS EQUAL TO OR LESS THAN FIFTEEN PERCENT
- 6 OF THE TOTAL KIDNEY DIALYSIS PROGRAM PROVIDED BY DEER'S HEAD CENTER
- 7 AND WESTERN MARYLAND CENTER SHALL REMAIN IN THE FUND TO BE USED FOR
- 8 THE PURPOSE SPECIFIED IN PARAGRAPH (2) OF THIS SUBSECTION.
- 9 (4) ANY UNSPENT PORTIONS IN EXCESS OF FIFTEEN PERCENT OF THE
- $10\,$  TOTAL KIDNEY DIALYSIS PROGRAM MAY BE TRANSFERRED OR REVERTED TO THE
- 11 GENERAL FUND OF THE STATE.
- 12 (F) THE SECRETARY OR THE SECRETARY'S DESIGNEE SHALL ADMINISTER
- 13 THE FUND AND THE MONEYS IN THE FUND MAY BE EXPENDED ONLY FOR THE
- 14 PURPOSES SPECIFIED IN THIS SECTION.
- 15 (G) THE LEGISLATIVE AUDITOR MAY AUDIT THE ACCOUNTS AND
- 16 TRANSACTIONS OF THE FUND AS PROVIDED IN § 2-1215 OF THE STATE GOVERNMENT
- 17 ARTICLE.
- 18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall ensure
- 19 that any moneys accrued up until October 1, 1996 do not revert and shall be paid into the
- 20 Deer's Head Center and Western Maryland Center Dialysis Fund.
- 21 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 22 October 1, 1996.
