11 Article 5 - Public Local Laws of Maryland

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:
15 Article 5 - Calvert County
16 5-103.
17 (a) The [commissioners] COUNTY COMMISSIONERS may change an adopted
18 budget only by resolutions that comply with this section, the Maryland Constitution, state
19 laws or public local laws. Changes may not be subdivided to alter the applicability of the
20 requirements of this section.
21 (b) The [commissioners] COUNTY COMMISSIONERS by resolution may establish
22 procedures for the administrative transfer of appropriations between general
23 classifications of expenditures in the current expense budget within the same office or

24 department, TRANSFERS BETWEEN DEPARTMENTS, AGENCIES, BOARDS, OR

- 1 COMMISSIONS, interproject transfers of appropriations between capital projects in the
- 2 capital budget, and the addition of new budget items. [However, only changes involving
- 3 less than \$5,000 each may be made under this subsection.
- 4 (c) Transfers or additions involving an amount of \$5,000 or more, ortransfers
- $5\,$ between departments, agencies, boards, or commissions may be made only by resolution
- 6 approved by the commissioners.
- 7 (d)] (C) Any change involving funds totaling more than \$50,000 may be made
- 8 only by resolution approved by the commissioners after compliance with the publication
- 9 and hearing requirements applicable to the original proposed budget.
- 10 [(e)] (D) To meet a public emergency affecting life, health, or property, the
- 11 commissioners by resolution may make emergency appropriations from contingent or
- 12 surplus funds.
- 13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 14 July 1, 1996.
