- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 11 MARYLAND, That the Laws of Maryland read as follows:

- 14 Butter, oleomargarine, and margarine shall be offered and exposed for sale and sold
- 15 by weight[, and when in package form these commodities shall be packaged only in units
- 16 of 1/4 pound, 1/2 pound, 1 pound, or multiples of 1 pound, avoirdupois weight].
- 17 11-312.
- 18 (a) All fluid dairy products, including whole milk, skimmed milk, cultured milk,
- 19 sweet cream, and buttermilk shall be [packaged for retail sale only in units of 1 gill,
- 20 one-half liquid pint, 10 fluid ounces, 12 fluid ounces, 1 liquid pint, 1 liquid quart, or
- 21 multiples of 1 quart. However, packages in units of less than 1 gill shall be permitted]
- 22 SOLD BY FLUID VOLUME.
- 23 (b) [(1) Except as provided in paragraph (2) of this subsection, cottage]
- 24 COTTAGE cheese, cottage cheese products, sour cream, and yogurt shall be [packaged
- 25 for retail sale only in the following weights:
- 26 (i) 8, 12, 16, 24, 32, 64, 80, and 128 ounces avoirdupois;
- 27 (ii) 250, 375, 500, and 750 grams; and
- 28 (iii) 1, 2, and 4 kilograms.

1	(2) Multipack or single serving sizes of cottage cheese, cottage cheese products, sour cream, and yogurt shall be sold only in the following weights:
3	(i) If in sizes of 6 ounces or less, in whole ounce increments; or

8 9 10 11	(c) (1) Ice cream, ice milk, French ice cream, French custard ice cream, frozen custard, frozen dietary dairy dessert, frozen yogurt, mellorine, parevine, sherbert, water ice, fruit ice, dietary frozen dessert, quiescently frozen confection, or quiescently frozen dairy confection, and any products which are similar in appearance, odor, or taste to such products or are prepared or frozen as such products are customarily prepared or frozen, whether made with dairy products or nondairy products, together with the mixes used in such products and for which a standard has been promulgated by the Secretary of Health and Mental Hygiene, shall be [deemed a liquid.
16 17 18	(2) Except as provided in paragraph (3) of this subsection, the commodities in paragraph (1) of this subsection, when sold or offered for sale in packages or containers containing one-half pint to and including 1 gallon, shall be packaged only in units of one-half pint, 1 pint, 1 quart, one-half gallon, and 1 gallon. However, packages in units of less than one-half pint are allowed] KEPT, OFFERED, AND EXPOSED FOR SALE AND SOLD BY FLUID VOLUME.
	[(3)] (2) Frozen yogurt shall be sold or offered for sale by weight, whether or not combined with other condiments, if the amount of the frozen yogurt to be purchased is:

24	(ii) Dispensed by the purchaser.

28 29 30 31 32	[When in package form, and when packed, possessed, offered, or exposed for sale or sold at retail, wheat] WHEAT flour, whole wheat flour, graham flour,self-rising wheat flour, phosphated wheat flour, bromated flour, enriched flour, enrichedself-rising flour, enriched bromated flour, corn flour, cornmeal, and hominy grits shall be [packaged only in units of 2, 5, 10, 25, 50, or 100 pounds, or multiples of 100 pounds, avoirdupois weight. However, this section does not apply to prepared ready-mixed flours andmeals, and special cake flours in packages the net contents of which are less than5 pounds] KEPT, OFFERED, AND EXPOSED FOR SALE AND SOLD BY WEIGHT.
