A BILL ENTITLED

1 AN ACT concerning

2 Utilization Review of Hospital Services - Minimum Length of Stay - Cesarean Section

- 3 FOR the purpose of requiring private review agents and health maintenance
- 4 organizations to follow certain guidelines with regard to length of hospital stay for
- 5 services related to maternity and newborn care following a cesarean section.
- 6 BY repealing and reenacting, with amendments,

- 10 (1990 Replacement Volume and 1995 Supplement)
- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 12 MARYLAND, That the Laws of Maryland read as follows:
- 13 Article Health General
- 14 19-1305.4.
- 15 (a) Except as provided in subsection (b) of this section, the criteria and standards
- 16 used by a private review agent or health maintenance organization in performing
- 17 utilization review of hospital services related to maternity and newborn care, including
- 18 length of stay, shall be in accordance with the medical criteria outlined in the most
- 19 current version of the "Guidelines for Perinatal Care" prepared by the American
- 20 Academy of Pediatrics and the American College of Obstetricians and Gynecologists.
- 21 (b) (1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,
- 22 A private review agent or health maintenance organization may authorize shorter length
- 23 of hospital stay for services related to maternity and newborn care provided the newborn
- 24 meets the criteria for medical stability in the "Guidelines for Perinatal Care" and the
- 25 private review agent or health maintenance organization authorizes for the mother and
- 26 child an initial postpartum home visit which would include the collection of an adequate
- 27 sample for the hereditary and metabolic newborn screening, when indicated.

- 1 (2) FOR A CESAREAN SECTION, A PRIVATE REVIEW AGENT OR HEALTH
- 2 MAINTENANCE ORGANIZATION IN PERFORMING UTILIZATION REVIEW OF
- 3 HOSPITAL SERVICES RELATED TO MATERNITY AND NEWBORN CARE, INCLUDING
- 4 LENGTH OF STAY SHALL FOLLOW THE MEDICAL CRITERIA OUTLINED IN THE MOST
- 5 CURRENT VERSION OF THE "GUIDELINES FOR PERINATAL CARE" PREPARED BY THE
- 6 AMERICAN ACADEMY OF PEDIATRICS AND THE AMERICAN COLLEGE OF
- 7 OBSTETRICIANS AND GYNECOLOGISTS.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 9 October 1, 1996.
