20	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MA	ARYLAND, That:
22	(1) Subject to the provisions of paragraph (2) of this section, the special taxing
23 are	a or district created by Chapter 117 of the Acts of 1924, as amended by Chapter 558 of

- 7 (2) Any contract, obligation, duty, liability, or penalty outstanding on behalf of the
- 8 special taxing area or district at the time it becomes a municipal corporation and any
- 9 right, privilege, asset, property or interest in property, claim, demand, or cause of action
- 10 of the special taxing district or area at the time it becomes a municipal corporation shall
- 11 be fully assumed by the municipal corporation.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 69-1 through
- 13 69-8, inclusive, and the chapter heading "Chapter 69. North Chevy Chase" of Article 16
- 14 Montgomery County of the Code of Public Local Laws of Maryland be repealed.
- 15 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be construed
- 16 retroactively and shall be applied to and interpreted to apply as of the date of
- 17 incorporation under Article XI-E of the Constitution of Maryland and Article 23A -
- 18 Corporations Municipal of the Annotated Code of Maryland.
- 19 SECTION 4. AND BE IT FURTHER ENACTED, That, subject to the provisions 20 of Section 3 of this Act, this Act shall take effect June 1, 1996.
