12 13 MAI	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF RYLAND, That the Laws of Maryland read as follows:

4 5	(3) "Children" means any natural, illegitimate, adopted, or posthumous children or stepchildren of the decedent who are:

	(4) "Correctional officer" means a member of a correctional unit who is responsible for the investigation, care, custody, control, or supervision of persons confined to places of incarceration.
14	(5) "Correctional unit" means any State or county governmental organization which has by statute, ordinance, or court order the responsibility for the care, control, and supervision of inmates in correctional institutions for persons declared to be parolees or for persons placed on probation or suspension of sentence.
16 17	(6) "Stepchild" means a child of the surviving spouse who was living with or dependent for support on the decedent at the time of his death.
18 19	(7) "State fire marshal" means any sworn member of the MarylandState Fire Marshal's Office.
22 23 24	(b) (1) A death benefit shall be paid to the surviving spouse, children, or dependent parents of any law enforcement officer of the State or of anypolitical subdivision of the State, any sheriff or deputy sheriff, any correctional officer, any volunteer or professional firefighter or rescue squad member or any State fire marshal, who is killed or dies in the performance of duties on or after July 1, 1989. The amount of the benefit shall be \$50,000.

- 3 (c) The payments for which this section provides shall be made out of funds which 4 the Governor may appropriate for that purpose in the State budget.
- 5 (d) The Secretary of Public Safety and Correctional Services may award a death 6 benefit under this section under any of the following circumstances provided the decision 7 is made on a case-by-case basis:
- 8 (1) If the decedent's death was caused by the decedent's intentional 9 misconduct;
- 10 (2) If the decedent intended to bring about the decedent's death; or
- 11 (3) If the decedent's voluntary intoxication was the proximate cause of the 12 decedent's death.
- 13 (e) Upon a determination by the Secretary of the Department of Public Safety 14 and Correctional Services that the [benefit] BENEFITS provided for in this section [is] 15 ARE to be paid, payment shall be made as follows:
- 16 (1) To the surviving spouse;

- 17 (2) If there is no surviving spouse, to the surviving child or children of the 18 decedent in equal shares; or
- 19 (3) If there is no surviving spouse, or children, to the surviving parent or 20 parents, if the parent was a dependent as defined in § 152 of the Internal Revenue Code.
- 21 (f) (1) Any person aggrieved by a final decision of the Secretary under this 22 section may apply for judicial review.
- 23 (2) The appeal shall be made as provided for review of final decisions in 24 Title 10, Subtitle 2 of the State Government Article of the Code.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to
- 26 funeral benefits for any law enforcement officer, correctional officer, volunteer or
- 27 professional firefighter or rescue squad member, or State fire marshal who is killed or
- 28 dies in the line of duty on or after the effective date of this Act.
- 29 SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency
- 30 measure, is necessary for the immediate preservation of the public health and safety, has
- 31 been passed by a yea and nay vote supported by three-fifths of all the members elected to
- 32 each of the two Houses of the General Assembly, and shall take effect from the date it is
- 33 enacted.
