5 FOR the purpose of creating in Prince George's County a new Class B-BWL-Stadium
6 alcoholic beverages license; specifying the license fee and days forsale; and
7 generally relating to alcoholic beverages in Prince George's County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That Section(s) 6-201(r)(13) of Article 2B - Alcoholic Beverages of the
3 Annotated Code of Maryland be renumbered to be Section(s) 5-201(r)(4).

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
5 read as follows:

6 **Article 2B - Alcoholic Beverages**

7 5-201.

8 (r) (4) (i) There is a Class [B-Stadium] B-BW-STADIUM beer and light
9 wine license.

10 (ii) The annual license fee is \$2,000.

11 (iii) The license is a special 7-day Class [B-Stadium] B-BW-STADIUM
12 (baseball stadium) license for on-sale consumption only for exclusive use on the premises
13 of a baseball stadium owned or operated by the Maryland-National Capital Park and
14 Planning Commission.

15 (iv) The license may be issued either to the Maryland-National Capital
16 Park and Planning Commission or to a private concessionaire that is under contract with
17 the Commission.

18 (v) Alcoholic beverages may be sold only by employees who are 18
19 years old or older.

20 (vi) The residency requirement specified by § 9-101 of this article does
21 not apply to an applicant for a Class B-Stadium license.

22 (vii) Any profit from the sale of beer or light wine made by the licensee
23 may accrue to the benefit and use of either the Commission or the concessionaire.

25 (R) (13) (I) THERE IS A CLASS B-BWL-STADIUM BEER, WINE AND LIQUOR
26 LICENSE.

27 (II) THE ANNUAL LICENSE FEE IS \$10,000.

28 (III) THE LICENSE IS A SPECIAL 7-DAY CLASS B-BWL-STADIUM
29 (FOOTBALL STADIUM) LICENSE FOR ON-SALE CONSUMPTION ONLY FOR EXCLUSIVE
30 USE ON THE PREMISES OF A FOOTBALL STADIUM. IT IS ONLY FOR THE SALE OF
31 BEER, WINE AND LIQUOR BY THE DRINK AND BY THE BOTTLE WITHIN THE
32 STADIUM, FROM ONE OR MORE OUTLETS.

33 (IV) ALCOHOLIC BEVERAGES MAY BE SOLD ONLY BY EMPLOYEES
34 WHO ARE 18 YEARS OLD OR OLDER.

35 (V) THE RESIDENCY REQUIREMENT SPECIFIED BY § 9-101 OF THIS
36 ARTICLE DOES NOT APPLY TO AN APPLICANT FOR A CLASS B-BWL-STADIUM
37 LICENSE.
