CHAPTER

1 AN ACT concerning

2 Deaf Students - Access to Out-of-State Specialized Educational Centers

- 3 FOR the purpose of authorizing deaf students on approval by the State Superintendent of
- 4 Schools to attend specialized educational centers outside the State if the deaf
- 5 student is a Maryland resident and resides over a certain distance from any branch
- of the Maryland School for the Deaf; and requiring the Department and the county
- 7 in which the deaf student resides to be responsible for providing certain
- 8 reimbursement to the specialized educational center.

- 11 Section 8-304.2
- 12 Annotated Code of Maryland
- 13 (1992 Replacement Volume and 1995 Supplement)
- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:
- 16 **Article Education**

- 18 (A) SUBJECT TO THE APPROVAL OF THE STATE SUPERINTENDENT, A DEAF
- 19 CHILD WHO IS A MARYLAND RESIDENT AND WHO RESIDES MORE THAN 50 MILES
- 20 FROM ANY BRANCH OF THE MARYLAND SCHOOL FOR THE DEAF SHALL HAVE THE
- 21 OPTION TO ATTEND A STATE APPROVED SPECIALIZED EDUCATIONAL CENTER FOR
- 22 THE DEAF OUTSIDE OF THE STATE.

- 1 (B) (1) THE DEPARTMENT AND THE COUNTY IN WHICH THE DEAF CHILD
- 2 RESIDES SHALL REIMBURSE THE SPECIALIZED EDUCATIONAL CENTER AS
- 3 PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION.
- 4 (2) (I) REIMBURSEMENT SHALL BE THE <u>DAY PLACEMENT</u> COST OF
- 5 THE SPECIALIZED EDUCATIONAL CENTER FOR THE DEAF, UP TO THE AMOUNT OF
- 6 THE PER-PUPIL <u>DAY PLACEMENT</u> COST OF THE MARYLAND SCHOOL FOR THE DEAF.
- 7 (II) IF THE DAY PLACEMENT COST OF THE SPECIALIZED
- 8 EDUCATIONAL CENTER FOR THE DEAF EXCEEDS THE PER-PUPIL <u>DAY PLACEMENT</u>
- 9 COST OF THE MARYLAND SCHOOL FOR THE DEAF, THE PARENTS SHALL BE
- 10 RESPONSIBLE FOR ANY ADDITIONAL COSTS.
- 11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 12 October 1, 1996.
