	CHAPTER

1 AN ACT concerning

2 Creation of a State Debt - Montgomery County - Strathmore Hall Arts Center

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$250,000, the
- 4 proceeds to be used as a grant to the Board of Trustees of the Strathmore Hall
- 5 Foundation, Inc. for certain acquisition, development, or improvement purposes;
- 6 providing for disbursement of the loan proceeds, subject to a requirement that the
- 7 grantee provide and expend a matching fund; requiring the grantee togrant and
- 8 convey a certain easement to the Maryland Historical Trust; and providing generally
- 9 for the issuance and sale of bonds evidencing the loan.
- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11 MARYLAND, That:
- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the Montgomery
- 14 County Strathmore Hall Arts Center Loan of 1996 in a total principal amount equal to
- 15 the lesser of (i) \$250,000 or (ii) the amount of the matching fund provided in accordance
- 16 with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of
- 17 State general obligation bonds authorized by a resolution of the Board of Public Works
- 18 and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of the State
- 19 Finance and Procurement Article and Article 31, § 22 of the Code.
- 20 (2) The bonds to evidence this loan or installments of this loan maybe sold as a
- 21 single issue or may be consolidated and sold as part of a single issue of bonds under §
- 22 8-122 of the State Finance and Procurement Article.
- 23 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and
- 24 first shall be applied to the payment of the expenses of issuing, selling, and delivering the
- 25 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on
- 26 the books of the Comptroller and expended, on approval by the Board of Public Works,

- 1 for the following public purposes, including any applicable architects'and engineers' fees:
- 2 as a grant to the Board of Trustees of the Strathmore Hall Foundation, Inc. (referred to
- 3 hereafter in this Act as "the grantee") for the completion of the expansion and renovation
- 4 of, and for the provision of capital equipment for, the Strathmore HallArts Center in
- 5 Montgomery County.
- 6 (4) An annual State tax is imposed on all assessable property in the State in rate 7 and amount sufficient to pay the principal of and interest on the bonds, as and when due 8 and until paid in full. The principal shall be discharged within 15 years after the date of
- 9 issuance of the bonds.
- 10 (5) Prior to the payment of any funds under the provisions of this Act for the
- 11 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching
- 12 fund. No part of the grantee's matching fund may be provided, either directly or
- 13 indirectly, from funds of the State, whether appropriated or unappropriated. No part of
- 14 the fund may consist of real property or in kind contributions. The fund may consist of or
- 15 funds expended prior to the effective date of this Act. In case of any dispute as to the
- 16 amount of the matching fund or what money or assets may qualify as matching funds, the
- 17 Board of Public Works shall determine the matter and the Board's decision is final. The
- 18 grantee has until June 1, 1998, to present evidence satisfactory to the Board of Public
- 19 Works that a matching fund will be provided. If satisfactory evidence is presented, the
- 20 Board shall certify this fact and the amount of the matching fund to the State Treasurer,
- 21 and the proceeds of the loan equal to the amount of the matching fund shall be expended
- 22 for the purposes provided in this Act. Any amount of the loan in excess of the amount of
- 23 the matching fund certified by the Board of Public Works shall be canceled and be of no
- 24 further effect.
- (6) (a) Prior to the issuance of the bonds, the grantee shall grant and convey to
- 26 the Maryland Historical Trust a perpetual preservation easement to the extent of its
- 27 interest:
- 28 (i) On the land or such portion of the land acceptable to the Trust;
- 29 and
- (ii) On the exterior and interior, where appropriate, of the historic 30
- 31 structures.
- 32 (b) The easement must be in form and substance acceptable to the Trust
- 33 and the extent of the interest to be encumbered must be acceptable to the Trust.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 34
- 35 June 1, 1996.
