## 2 Pharmacists - Licensure - Oral Competency Exams

- 3 FOR the purpose of authorizing the State Board of Pharmacy to waive certain
- 4 qualifications for a license to practice pharmacy under certain circumstances;
- 5 requiring applicants for a license to practice pharmacy to demonstrate oral
- 6 competency in the English language; requiring the Board to adopt certain
- 7 regulations; requiring certain licensees to pass a certain test; making a certain
- 8 exception; defining a certain term; and generally relating to the requirement that
- 9 applicants for a license to practice pharmacy demonstrate oral competency in the
- 10 English language.

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

## 18 **Article - Health Occupations**

- 20 (a) To qualify for a license, an applicant shall be an individual who meets the
- 21 requirements of this section.
- (b) The applicant shall be of good moral character.
- 23 (c) The applicant shall be at least 18 years old.

- 2 (1) Be a graduate of a school or college of pharmacy that is approved by the
- 3 Board or accredited by the American Council on Pharmaceutical Education; and
- 4 (2) Have completed the clinical pharmacy training that the Board requires.
- 5 (e) Except as otherwise provided in this title, the applicant shall pass an
- 6 examination given by the Board under this subtitle.
- 7 (F) (1) IN THIS SUBSECTION, "FOREIGN SCHOOL OR COLLEGE OF
- 8 PHARMACY" MEANS A SCHOOL OR COLLEGE OF PHARMACY THAT IS NOT LOCATED
- 9 IN ANY STATE IN THE UNITED STATES.
- 10 (2) THE BOARD MAY WAIVE THE REQUIREMENTS OF SUBSECTION (D)(1)
- 11 OF THIS SECTION FOR AN APPLICANT WHO IS A GRADUATE OF A FOREIGN SCHOOL
- 12 OR COLLEGE OF PHARMACY, PROVIDED THAT THE APPLICANT PASSES AN
- 13 EXAMINATION APPROVED BY THE BOARD IN ADDITION TO THE EXAMINATIONS
- 14 OTHERWISE GIVEN BY THE BOARD UNDER THIS SUBTITLE.
- 15 (G) (1) THE BOARD SHALL REQUIRE, AS PART OF ITS EXAMINATION OR
- 16 LICENSING PROCEDURES, AN APPLICANT FOR A LICENSE TO PRACTICE PHARMACY
- 17 TO DEMONSTRATE AN ORAL COMPETENCY IN THE ENGLISH LANGUAGE BY PASSING
- 18 A BOARD APPROVED STANDARDIZED TEST OF ORAL COMPETENCY.
- 19 (2) THE BOARD SHALL ADOPT REGULATIONS THAT ESTABLISH A
- 20 PROCEDURE FOR TESTING AN INDIVIDUAL WHO BECAUSE OF THE INDIVIDUAL'S
- 21 SPEECH OR HEARING IMPAIRMENT IS UNABLE TO COMPLETE SATISFACTORILY A
- 22 BOARD APPROVED STANDARDIZED TEST OF ORAL COMPETENCY.
- 23 (3) IF ANY DISCIPLINARY CHARGE OR ACTION THAT RELATES TO A
- 24 PROBLEM WITH THE ORAL COMMUNICATION OF THE ENGLISH LANGUAGE IS
- 25 BROUGHT AGAINST A LICENSEE UNDER THIS TITLE, THE BOARD SHALL REQUIRE
- 26 THE LICENSEE TO PASS A BOARD APPROVED STANDARDIZED TEST OF ORAL
- 27 COMPETENCY.
- 28 (4) THE BOARD MAY NOT REQUIRE AN APPLICANT FOR A LICENSE TO
- 29 PRACTICE PHARMACY, WHO WAS PREVIOUSLY LICENSED IN ANOTHER STATE TO
- 30 PRACTICE PHARMACY, TO DEMONSTRATE AN ORAL COMPETENCY IN THE ENGLISH
- 31 LANGUAGE, IF THE OTHER STATE'S EXAMINATION AND LICENSING PROCEDURES AT
- 32 THE TIME THE APPLICANT WAS LICENSED IN THE OTHER STATE INCLUDED AN ORAL
- 33 COMPETENCY COMPONENT SIMILAR TO THE ORAL COMPETENCY COMPONENT IN
- 34 THIS STATE'S EXAMINATION AND LICENSING PROCEDURES.
- 35 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 36 October 1, 1996.
