- 17 MARYLAND, That the Laws of Maryland read as follows:

- 20 (A) IN ADDITION TO THE POWERS OTHERWISE GRANTED TO THE COUNTY
- 21 BOARD IN THIS ARTICLE, THE COUNTY BOARD OR A DESIGNATED COMMITTEE OF
- 22 THE COUNTY BOARD MAY HEAR AN APPEAL FROM A DECISION OF THE COUNTY
- 23 SUPERINTENDENT THAT RELATES TO THE GRADE, TRANSFER, TUITION, OR ANY
- 24 ASPECT OF PARTICIPATION IN A PROGRAM OR ACTIVITY OF A SPECIFIC STUDENT
- 25 WHO IS NOT SUBJECT TO THE PROVISIONS OF TITLE 8, SUBTITLE 4 OF THIS ARTICLE.
- 26 (B) A DESIGNATED COMMITTEE SHALL CONSIST OF AT LEAST 5 MEMBERS OF
- 27 THE BOARD AND AT LEAST 5 MEMBERS OF A DESIGNATED COMMITTEE SHALL BE
- 28 PRESENT TO CONSTITUTE A QUORUM OF THE COMMITTEE.
- 29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 30 October 1, 1996.
