## 2 Insurance - Change of Agent of Record or Broker of Record

- 3 [TAG ftpo]FOR the purpose of requiring certain authorized insurers to accept and honor requests
- 4 for a change of agent of record or broker of record within a certain time period;
- 5 requiring a new agent or broker of record to have a current appointmentor contract
- 6 with the authorized insurer before the change of agent or broker of record will be
- 7 effective; requiring a new agent of record or broker of record to be paid certain
- 8 compensation commissions under certain circumstances; requiring a request for a
- 9 change of agent of record or broker of record to be in writing and include certain
- 10 information; providing that this Act does not require authorized insurers to appoint
- 11 or contract with agents or brokers; and generally relating to a change of agent of
- 12 record or broker of record in insurance.

- 19 MARYLAND, That the Laws of Maryland read as follows:

- 22 (A) EACH <u>AUTHORIZED</u> INSURER <del>AUTHORIZED TO DO</del> <u>DOING</u> BUSINESS IN
- 23 THE STATE SHALL ACCEPT AND HONOR EACH REQUEST BY A POLICYHOLDER FOR A
- 24 CHANGE OF AGENT <del>OF RECORD</del> OR <u>A CHANGE OF</u> BROKER OF RECORD WITHIN <del>10</del> <u>30</u>

- 1 WORKING DAYS AFTER RECEIPT OF THE REQUEST UNLESS THE POLICYHOLDER OR
- 2 INSURED WITHDRAWS THE REQUEST IN WRITING.
- 3 (B) THE NEW AGENT OR BROKER OF RECORD MUST HAVE A CURRENT
- 4 APPOINTMENT OR CONTRACT WITH THE AUTHORIZED INSURER BEFORE THE
- 5 CHANGE OF AGENT OR BROKER OF RECORD WILL BE EFFECTIVE.
- 6 (B) (C) THE NEW AGENT OF RECORD OR NEW BROKER OF RECORD SHALL
- 7 BE PAID ALL COMPENSATION EARNED COMMISSIONS PAYABLE ON THE POLICY
- 8 EFFECTIVE FROM THE FIRST ANNIVERSARY DATE OF THE POLICY FOLLOWING THE
- 9 DATE OF CHANGE.
- 10 (C) (D) A REQUEST FOR A CHANGE OF AGENT OF RECORD OR BROKER OF 11 RECORD SHALL:
- 12 (1) BE IN WRITING; AND
- 13 (2) INCLUDE:
- 14 (I) THE <u>POLICYHOLDER'S OR</u> INSURED'S NAME AND ADDRESS;
- 15 (II) THE <u>AUTHORIZED</u> INSURER'S NAME AND ADDRESS;
- 16 (III) THE POLICY NUMBER;
- 17 (IV) THE NAME AND ADDRESS OF THE NEW AGENT OR BROKER OF
- 18 RECORD;
- 19 (IV) (V) THE DATE OF THE REQUEST; AND
- 20 (V) (VI) THE SIGNATURE OF THE POLICYHOLDER OR INSURED.
- 21 (E) THIS SECTION DOES NOT REQUIRE AUTHORIZED INSURERS TO APPOINT
- 22 OR CONTRACT WITH AGENTS OR BROKERS.
- 23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 24 October 1, 1996.
