## 1 AN ACT concerning

- 2 Creation of a State Debt Baltimore Children's Museum Maryland Consolidated
- 3 Capital Bond Loan of 1995 and Baltimore Children's Museum Loan of 1995
- 4 [TAG ftpo]FOR the purpose of authorizing the creation of a State Debt not to exceed \$1,000,000
- 5 \$750,000, the proceeds to be used as a grant to the Board of Directors of the
- 6 Baltimore Children's Museum, Inc. for certain planning, acquisition, development,
- 7 or improvement purposes; providing for disbursement of the loan proceeds, subject
- 8 to a requirement that the grantee provide and expend a matching fund; requiring
- 9 the grantee to grant and convey to the Maryland Historical Trust a historic
- 10 preservation easement; clarifying the use of the proceeds of the grant; and providing
- 11 generally for the issuance and sale of bonds evidencing the loan; amending Chapter
- 12 115 of the Acts of the General Assembly of 1994, as amended by Chapter 131 of the
- 13 Acts of the General Assembly of 1995, to alter the purposes of the grant to the
- 14 Baltimore Children's Museum and to clarify the use of the proceeds of the grant;

## 1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 2 MARYLAND. That:

- 3 (1) The Board of Public Works may borrow money and incur indebtedness on
- 4 behalf of the State of Maryland through a State loan to be known as the Baltimore
- 5 Children's Museum Loan of 1996 in a total principal amount equal to thelesser of (i)
- 6 \$1,000,000 \$750,000 or (ii) the amount of the matching fund provided inaccordance with
- 7 Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of
- 8 State general obligation bonds authorized by a resolution of the Board of Public Works
- 9 and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of the State
- 10 Finance and Procurement Article and Article 31, § 22 of the Code.
- 11 (2) The bonds to evidence this loan or installments of this loan maybe sold as a
- 12 single issue or may be consolidated and sold as part of a single issue of bonds under §
- 13 8-122 of the State Finance and Procurement Article.
- 14 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and
- 15 first shall be applied to the payment of the expenses of issuing, selling, and delivering the
- 6 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on
- 17 the books of the Comptroller and expended, on approval by the Board of Public Works,
- 18 for the following public purposes, including any applicable architects'and engineers' fees:
- 19 as a grant to the Board of Directors of the Baltimore Children's Museum, Inc. (referred
- 20 to hereafter in this Act as "the grantee") for the acquisition of real property and for the
- 21 planning, design, construction, alteration, and renovation of, for the provision of
- 22 equipment and furnishings for, and for the installation of exhibits at, renovation,
- 23 <u>furnishing</u>, and capital equipping of the Baltimore Children's Museum, to be located at
- 24 Market Place in Baltimore City, adjacent to and including an existing open-air plaza, the
- 25 grant to include including expenses incurred by the grantee for:
- 26 (a) the preparation of a master plan for the area immediately surrounding
- 27 and related to the Children's Museum;
- 28 (b) the securing of third party construction, and development and
- 29 management of services in connection with the planning, design, construction, alteration,
- 30 renovation, equipping, and furnishing of the Children's Museum; and
- 31 (c) the planning, design, construction, and purchase of exhibits furnishings.
- 32 fixtures, and capital equipment for the Children's Museum.
- 33 (4) An annual State tax is imposed on all assessable property in the State in rate
- 34 and amount sufficient to pay the principal of and interest on the bonds, as and when due
- 35 and until paid in full. The principal shall be discharged within 15 years after the date of
- 36 issuance of the bonds.
- 37 (5) Prior to the payment of any funds under the provisions of this Act for the
- 38 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching
- 39 fund. No part of the grantee's matching fund may be provided, either directly or
- 40 indirectly, from funds of the State, whether appropriated or unappropriated. No part of
- 41 the fund may consist of real property, in kind contributions, or funds expended prior to
- 42 the effective date of this Act. or in kind contributions. The fund may consist of funds
- 43 expended prior to the effective date of this Act, including grant fundsreceived from the

- 1 Mayor and City Council of Baltimore or funds received from private sources, all of which
- 2 the grantee has expended for uses permitted under this Act or for othercosts and
- 3 expenses incurred by the grantee in the planning, design, construction, alteration,
- 4 renovation, furnishing, and equipping of the Children's Museum, and in the planning,
- 5 design, acquisition, fabrication, and installation of exhibits to be displayed in the
- 6 Children's Museum. In case of any dispute as to the amount of the matching fund or what
- 7 money or assets may qualify as matching funds, the Board of Public Works shall
- 8 determine the matter and the Board's decision is final. The grantee hasuntil June 1,
- 9 1998, to present evidence satisfactory to the Board of Public Works that a matching fund
- 10 will be provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 11 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 12 equal to the amount of the matching fund shall be expended for the purposes provided in
- 13 this Act. Any amount of the loan in excess of the amount of the matching fund certified
- 14 by the Board of Public Works shall be canceled and be of no further effect.
- 15 (6) (a) As provided in § 8-127(b)(1)(ii)(i) of the State Finance and
- 16 Procurement Article, the grantee may expend the proceeds of the grant for expenses
- 17 incurred by the grantee in connection with the planning, design, construction, and
- 18 purchase of equipment, exhibits, and furnishings alteration, renovation, equipping, and
- 19 furnishing, as permitted in this Act.
- 20 (b) The improvements for which the funds are expended are not required to
- 21 be capital improvements within the meaning of § 8-127(b)(2) of the State Finance and
- 22 Procurement Article or the regulations or guidelines of the Board of Public Works.
- 23 (7) (a) Prior to the issuance of the bonds, the grantee shall grant and convey to
- 24 the Maryland Historical Trust a perpetual preservation easement to the extent of its
- 25 interest:
- 26 (i) On the land or such portion of the land acceptable to the Trust;
- 27 and
- 28 (ii) On the exterior and interior, where appropriate, of the historic
- 29 structures.
- 30 (b) The easement must be in form and substance acceptable to the Trust
- 31 and the extent of the interest to be encumbered must be acceptable to the Trust.

This loan shall be evidenced by the issuance, sale, and delivery of State 2 general obligation bonds authorized by a resolution of the Board of Public Works and 3 issued, sold, and delivered in accordance with §§ 8 117 through 8 124 of the State 4 Finance and Procurement Article and Article 31, § 22 of the Code. 5 (2) The bonds to evidence this loan or installments of this loan maybe sold as a 6 single issue or may be consolidated and sold as part of a single issue of bonds under § 8-122 of the State Finance and Procurement Article. 8 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and 9 first shall be applied to the payment of the expenses of issuing, selling, and delivering the bonds, unless funds for this purpose are otherwise provided, and then shall be credited on the books of the Comptroller and expended, on approval by the Board of Public Works, 11 for the following public purposes, including any applicable architects'and engineers' fees: as a grant to the Baltimore Children's Museum, Inc. (referred to hereafter in this Act as 14 "the grantee") for the acquisition of real property and for the planning, design, 15 construction, alteration, AND renovation OF, [and equipping of] FOR THEPROVISION 16 OF EQUIPMENT AND FURNISHINGS FOR, AND FOR THE INSTALLATION OF EXHIBITS AT the Baltimore Children's Museum, TO BE LOCATED AT MARKET PLACE IN 18 BALTIMORE CITY, ADJACENT TO AND INCLUDING AN EXISTING OPEN AIR PLAZA. THE GRANT TO INCLUDE EXPENSES INCURRED BY THE GRANTEE FOR: 20 (A) THE PREPARATION OF A MASTER PLAN FOR THE AREA 21 IMMEDIATELY SURROUNDING THE CHILDREN'S MUSEUM: 22 (B) THE SECURING OF THIRD PARTY CONSTRUCTION, DEVELOPMENT AND MANAGEMENT OF SERVICES IN CONNECTION WITH THE CONSTRUCTION, ALTERATION, RENOVATION, EQUIPPING, AND FURNISHING OF THE CHILDREN'S 25 MUSEUM; AND 26 (C) THE PLANNING, DESIGN, CONSTRUCTION, AND PURCHASE OF 27 EXHIBITS FOR THE CHILDREN'S MUSEUM. 28 (4) An annual State tax is imposed on all assessable property in the State in rate 29 and amount sufficient to pay the principal of and interest on the bondsas and when due and until paid in full. The principal shall be discharged within 15 years after the date of issuance of the bonds. 32 (5) Prior to the payment of any funds under the provisions of this Act for the 33 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching fund. No part of the grantee's matching fund may be provided, either directly or 35 indirectly, from funds of the State, whether appropriated or unappropriated. No part of the fund may consist of real property, in kind contributions, or funds expended prior to the effective date of this Act. In case of any dispute as to the amount of the matching fund or what money or assets may qualify as matching funds, the Board of Public Works 39 shall determine the matter and the Board's decision is final. The grantee has until June 1, 1997, to present evidence satisfactory to the Board of Public Works that a matching fund 41 will be provided. If satisfactory evidence is presented, the Board shall certify this fact and 42 the amount of the matching fund to the State Treasurer, and the proceeds of the loan

(7) (A) AS PROVIDED IN § 8-127(B)(1)(II) OF THE STATE FINANCE AND 12 13 PROCUREMENT ARTICLE, THE GRANTEE MAY EXPEND THE PROCEEDS OF THE 14 GRANT FOR EXPENSES INCURRED BY THE GRANTEE IN CONNECTION WITH THE 15 PLANNING, DESIGN, CONSTRUCTION, AND PURCHASE OF EQUIPMENT, EXHIBITS, 16 AND FURNISHINGS. 17 (B) THE IMPROVEMENTS FOR WHICH THE FUNDS ARE EXPENDED ARE 18 NOT REQUIRED TO BE CAPITAL IMPROVEMENTS WITHIN THE MEANING OF § 19 8-127(B)(2) OF THE STATE FINANCE AND PROCUREMENT ARTICLE OR THE 20 REGULATIONS OR GUIDELINES OF THE BOARD OF PUBLIC WORKS.
