A BILL ENTITLED

1 AN ACT concerning

2 Maryland Health Care Access and Cost Commission - Collection of Data

3 FOR the purpose of establishing a certain limitation on a certain demographic

- 4 characteristic of patients contained in the Maryland medical care data base;
- 5 requiring the Maryland Health Care Access and Cost Commission to eliminate
- 6 certain encrypted patient identifiers after a certain event; and generally relating to
- 7 the collection of data by the Maryland Health Care Access and Cost Commission.

8 BY repealing and reenacting, with amendments,

- 11 Annotated Code of Maryland
- 12 (1990 Replacement Volume and 1995 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

14 MARYLAND, That the Laws of Maryland read as follows:

15 Article - Health - General

16 19-1507.

(b) In addition to any other information the Commission may require byregulation, the medical care data base shall:

(1) Collect for each type of patient encounter with a health care practitioneror office facility designated by the Commission:

(i) The demographic characteristics of the patient, EXCEPTTHAT THE DATE OF BIRTH OF A PATIENT MAY NOT CONTAIN MORE THAN THE MONTH AND YEAR OF BIRTH;

24 (ii) The principal diagnosis;
25 (iii) The procedure performed;
26 (iv) The date and location of where the procedure was performed;

1 (vi) If the bill for the procedure was submitted on an assigned or 2 nonassigned basis; and

3 (vii) If applicable, a health care practitioner's universal identification 4 number;

5 (2) Collect appropriate information relating to prescription drugs for each 6 type of patient encounter with a pharmacist designated by the Commission; and

7 (3) Collect appropriate information relating to health care costs, utilization,8 or resources from payors and governmental agencies.

9 (d) (1) To the extent practicable, when collecting the data requiredunder 10 subsection (b) of this section, the Commission shall utilize any standardized claim form or 11 electronic transfer system being used by health care practitioners, office facilities, and 12 payors.

(2) The Commission shall develop appropriate methods for collecting the
data required under subsection (b) of this section on subscribers or enrollees of health
maintenance organizations.

16 (3) FOR ANY ENCRYPTED PATIENT IDENTIFIER SUBMITTED TO THE
17 COMMISSION BY A PAYOR, HEALTH CARE PRACTITIONER, OR OFFICE FACILITY, THE
18 COMMISSION SHALL ELIMINATE THE PATIENT IDENTIFIER AFTER EDITING THE
19 DATA FROM THE PATIENT IDENTIFIER.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 October 1, 1996.
