11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:
13 Article - Real Property
14 12-205.
15 (a) Whenever a program or project undertaken by a displacing agency will result
16 in the displacement of any person, the displacing agency shall make a payment to the
17 displaced person, on proper application as approved by the displacing agency for:
18 (1) Actual reasonable expenses in moving himself, his family, business, farm
19 operation, or other personal property;
20 (2) Actual direct loss of tangible personal property as a result of moving or
21 discontinuing a business or farm operation, but not exceeding an amountequal to the

- 1 reasonable expenses that would have been required to relocate the personal property, as 2 determined by the agency;
- 3 (3) Actual reasonable expenses in searching for a replacement business or
- 4 farm; and

- 5 (4) Actual reasonable expenses necessary to reestablish a displaced farm, 6 nonprofit organization, or small business at its new site as determined by the displacing 7 agency, but not to exceed \$10,000.
- 8 (b) Any displaced person eligible for payments under subsection (a) of this 9 section, who is displaced from a dwelling and who elects to accept the payments 10 authorized by this subsection in lieu of the payments authorized by subsection (a) of this 11 section, may receive a moving expense allowance, determined according to a schedule
- 13 (c) (1) Any displaced person eligible for payments under subsection (a) of this
 14 section who is displaced from the person's place of business or farm operation and who is
 15 eligible under criteria established by the lead agency may elect to accept the payment
 16 authorized by this subsection in lieu of the payment authorized by subsection (a) of this
 17 section.
- (2) Such payment shall consist of a fixed payment in an amount to be
 determined according to criteria established by the lead agency, exceptthat such payment
 may not be less than \$1,000 nor more than \$20,000 OR THE AMOUNT PROVIDED UNDER
 THE FEDERAL UNIFORM RELOCATION ASSISTANCE ACT, WHICHEVER IS GREATER.
- 22 (3) A person whose sole business at the displacement dwelling is the rental 23 of such property to others shall not qualify for a payment under this subsection.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 25 October 1, 1996.
