A BILL ENTITLED

1 AN ACT concerning

Design Professional Boards - Imposition of Monetary Penalties 2

3 FOR the purpose of authorizing the State Board of Architects, the StateBoard of

- 4 Examiners of Landscape Architects, the State Board for Professional Engineers,
- and the State Board for Professional Land Surveyors to impose certain monetary 5
- penalties on certain persons; and generally relating to the authority of the State 6
- 7 Board of Architects, the State Board of Examiners of Landscape Architects, the
- State Board for Professional Engineers, and the State Board for Professional Land 8
- 9 Surveyors to impose monetary penalties.

10 BY repealing and reenacting, with amendments,

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15
