A BILL ENTITLED

1 AN ACT concerning

2 Sale or Transfer of Regulated Firearms - Use of Facsimile Machine

- 3 FOR the purpose of authorizing the use of a facsimile machine to forward a certain
- 4 application form to the Secretary of the Department of State Police; correcting a
- 5 certain reference regarding the completion requirements of a certainapplication;

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

14 Article 27 - Crimes and Punishments

- 16 (a) All restrictions imposed by the laws, ordinances or regulations of all
- 17 subordinate jurisdictions within the State of Maryland on sales of pistols or revolvers are
- 18 superseded by this section, and the State of Maryland hereby preempts the rights of such
- 19 jurisdictions to regulate the sale of pistols and revolvers.
- 20 (b) No dealer shall sell or transfer any pistol or revolver until after seven days
- 21 shall have elapsed from the time an application to purchase or transfershall have been
- 22 executed by the prospective purchaser or transferee, in triplicate, and forwarded by the
- 23 prospective seller or transferor to the Secretary of the State Police.
- 24 (c) The dealer shall promptly after receiving an application to purchase or
- 25 transfer, completed in accordance with subsection [(e)] (F) below, forward one copy of
- 26 the same, [by certified mail] EITHER BY CERTIFIED MAIL OR BY USING A FACSIMILE
- 27 MACHINE, to the Secretary of the State Police. The copy forwarded to the Secretary shall
- 28 contain the name, address, and signature of the prospective seller or transferor. The
- 29 prospective seller or transferor shall retain one copy of the application for a period of not
- 30 less than three years. The prospective purchaser or transferee shall beentitled to the
- 31 remaining copy of the application.

| 8 | (e) The application to purchase or transfer shall bear the following legend: "Any false information supplied or statement made in this application is a crime which may be punished by imprisonment for a period of not more than three years, or a fine of not more than \$5,000, or both." |
| 10 11 | (f) The application to purchase or transfer shall contain the following information: |
| 14 | (1) Applicant's name, address, occupation, place and date of birth, height, weight, race, eye and hair color and signature. In the event the applicant is a corporation, the application shall be completed and executed by a corporate officer who is a resident of the jurisdiction in which the application is made. |
| 16 | (2) A statement by the applicant that he or she: |
| 19 | (i) Has never been convicted of a crime of violence, in this State or elsewhere, or of a violation of any of the provisions of §§ 286, 286A or 286C of this article or any conspiracy to commit any crimes established by those sections, or of any of the provisions of this subtitle. |
| 21 | (ii) Is not a fugitive from justice. |
| 22 | (iii) Is not a habitual drunkard. |
| 23 24 | (iv) Is not an addict or a habitual user of narcotics, barbiturates or amphetamines. |
| 27 28 | (v) Has never spent more than thirty consecutive days in any medical institution for treatment of a mental disorder or disorders, unless there is attached to the application a physician's certificate, issued within thirty days prior to the date of application, certifying that the applicant is capable of possessing a pistol or revolver without undue danger to himself or herself, or to others. |
| 30 | (vi) Is at least 21 years of age as required by federal law. |
| 31 32 | (vii) Has or has not submitted a prior application and, ifso, when and where. |
| 33 34 | (3) The date and hour the application was delivered in completed form to the prospective seller or transferor by the prospective purchaser or transferee. |
| 37 38 | (g) The Secretary of the State Police may request the assistance of the police commissioner of Baltimore City, the chief of police in any county maintaining a police force, or the sheriff in a county not maintaining a police force and shall promptly upon receipt of an application to purchase or transfer conduct an investigation in order to determine the truth or falsity of the information supplied and statements made in said |

- 1 application. If it be thereupon determined that any false information or statement has
- 2 been supplied or made by the applicant, or that the application has notbeen properly
- 3 completed, the Secretary or any specific member of the Department of State Police
- 4 authorized by the Secretary to act as the Secretary's agent in matters relating to pistol or
- 5 revolver sales shall notify the prospective seller or transferor, in writing, within seven days
- 6 from the date the executed application to purchase or transfer was forwarded by certified
- 7 mail OR BY FACSIMILE MACHINE, of his disapproval of said application. Written
- 8 notification of such disapproval shall be thereafter forwarded by the Secretary or the
- 9 Secretary's duly authorized agent or agents to the prospective purchaser or transferee.
- 10 The date upon which the executed application to purchase or transfer was forwarded by
- 11 certified mail OR BY FACSIMILE MACHINE TO THE SECRETARY by the prospective
- 12 seller or transferor shall be considered as the first day of the seven-day period allowed for
- 13 notice of disapproval to the said prospective seller or transferor. If the seventh day of the
- 14 seven-day period allowed for the said notice of disapproval shall fall on a Sunday or legal
- 15 holiday, the computation period shall be extended to the first day nextfollowing, which is
- 16 neither a Sunday nor a legal holiday.
- 17 (h) No dealer shall sell or transfer a pistol or revolver to an applicant whose
- 18 application has been timely disapproved, unless such disapproval has been subsequently
- 19 withdrawn by the Secretary of the State Police or the Secretary's duly authorized agent or
- 20 agents or overruled by the action of the courts pursuant to subsection (i) of this section.
- 21 (i) (1) Any prospective purchaser or transferee aggrieved by the action of the
- 22 Department of State Police may request a hearing within 30 days from the date when
- 23 written notice was forwarded to the aggrieved person by writing to the Secretary of the
- 24 State Police, who shall grant the hearing within fifteen days of the request.
- 25 (2) The hearing and subsequent proceedings of judicial review, if any,
- 26 thereupon following shall be conducted in accordance with the provisions of the
- 27 Administrative Procedure Act.
- 28 (3) The hearing shall be held in the county of the legal residence of the
- 29 aggrieved person. If the aggrieved person is not a State resident, the hearing shall be held
- 30 at a location designated by the Secretary of the State Police.
- 31 (j) Any dealer who sells or transfers a pistol or revolver in compliance with this
- 32 subtitle shall forward a copy of the written notification of such completed transaction,
- 33 within seven days from the date of delivery of the said pistol or revolver, to the Secretary
- 34 of the State Police, whose duty it shall be to maintain a permanent record of all such
- 35 completed sales and transfers of pistols and revolvers in the State. The notifications shall
- 36 contain an identifying description of the pistol or revolver sold or transferred including its
- 37 caliber, make, model, manufacturer's serial number, if any, and any other special or
- 38 peculiar characteristics or marking by which the said pistol or revolver may be identified.
- 39 (k) Nothing in this section shall be construed to affect sales and/or transfers for
- 40 bona fide resale in the ordinary course of business of a person duly licensed under § 443
- 41 of this subtitle, or sales, transfer, and/or the use of pistols or revolvers by any person
- 42 authorized or required to sell, transfer, and/or use such pistols or revolvers as part of his
- 43 or her duties as a member of any official police force or other law enforcement agency,
- 44 the armed forces of the United States, including all official reserve organizations, or the
- 45 Maryland National Guard.

- 1 (l) Any person who knowingly gives any false information or makes any material
 2 misstatement in an application required by this section, or who fails to promptly forward
 3 such application to the Secretary of the State Police or the Secretary's duly authorized
 4 agent or agents, or who sells or transfers a pistol or revolver to a person other than the
 5 one by whom application was made, or who otherwise sells, transfers, purchases, or
 6 receives transfer of a pistol or revolver in violation of this section, shall upon conviction
 7 thereof be subject to the penalties hereinafter provided in § 448 of this subtitle.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 1996.
