- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 11 MARYLAND, That the Laws of Maryland read as follows:

- 14 (a) The Office of People's Counsel shall evaluate all matters pending before the
- 15 Commission to determine if the interests of residential AND COMMERCIAL users of gas,
- 16 electricity, telephones, or water and sewerage or [of noncommercial] users of other
- 17 regulated services (hereinafter referred to as residential and [noncommercial]
- 18 COMMERCIAL users) are affected. It shall appear before the Commission and the courts
- 19 on behalf of those users in all matters or proceedings over which the Commission has
- 20 original jurisdiction and in which the Office of People's Counsel deemstheir interest to
- 21 be involved including, but not limited to, proceedings with regard to the rates, service, or
- 22 practices of any public service company or any violation of the provisions of this article. It
- 23 shall have, in such appearances, all the rights of counsel for a party to the proceeding,
- 24 including but not limited to those specified in § 82. The People's Counsel may appear
- 25 before any federal or State agency as necessary to protect the interests of residential and
- 26 [noncommercial] COMMERCIAL users.
- 27 (b) The Office of People's Counsel shall make such investigations and request the
- 28 Commission to initiate such proceedings as that Office deems necessary to protect the
- 29 interests of residential and [noncommercial] COMMERCIAL users.
- 30 (c) Consistent with the provisions of any applicable freedom of information act,
- 31 the Office of People's Counsel shall have full access to the Commission's records and,

- 1 except as hereinafter provided, shall have the benefit of all other facilities or information
- 2 of the Commission in carrying out its duties. The Office of People's Counsel shall be
- 3 entitled to call upon the assistance of the Commission staff if the staff determines that
- 4 this is consistent with the staff's responsibilities and if the staff and the Office of People's
- 5 Counsel agree that the sharing, in a particular matter, is consistent with their respective
- 6 interests.
- 7 (d) The Office of People's Counsel may recommend to the General Assembly
- 8 legislation on any matter within or related to the Commission's jurisdiction which in its
- 9 judgment would affect the interests of [noncommercial] COMMERCIAL or residential 10 users.
- 11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 12 October 1, 1996.
