- 2 (A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, THE AUTHORITY MAY
- 3 BORROW UP TO \$24,000,000, UNDER TERMS AND CONDITIONS THAT THE AUTHORITY
- 4 DETERMINES, FOR THE CONSTRUCTION OF THE FOOTBALL STADIUM, INCLUDING
- 5 THE CONSTRUCTION, FITTING OUT, AND FURNISHING OF THE PRIVATE SUITES THAT
- 6 ARE PART OF THE FOOTBALL STADIUM.
- 7 (B) THE FOOTBALL TEAM THAT LEASES THE STADIUM SHALL AGREE TO
- 8 REPAY THE AMOUNT BORROWED UNDER THE TERMS AND CONDITIONS
- 9 DETERMINED BY THE AUTHORITY.
- 10 (C) WITH RESPECT TO THE PRIVATE SUITES, THE PERIOD OF REPAYMENT
- 11 SHALL BE NOT LONGER THAN:
- 12 (1) 30 YEARS FOR CONSTRUCTION AND FITTING OUT; AND
- 13 (2) 5 YEARS FOR FURNISHINGS.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 July 1, 1996.
