A BILL ENTITLED

1 AN ACT concerning

2 Unemployment Insurance - Contributions

3 FOR the purpose of requiring that regulations adopted by the Secretary of Labor,

- 4 Licensing, and Regulation allow certain employing units to pay an estimated
- 5 contribution for a calendar year; specifying the amount of the estimated
- 6 contribution; providing for the manner of payment and adjustment of the estimated
- 7 contribution; and generally relating to payment of unemployment insurance
- 8 contributions by employing units.

9 BY repealing and reenacting, with amendments,

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 MARYLAND, That the Laws of Maryland read as follows:

16 Article - Labor and Employment

18 (d) (1) [By regulation,] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION,19 the Secretary BY REGULATION shall set:

20 (i) the date when contributions are due; and

(ii) the manner in which contributions are to be paid.

22 (2) (I) THE REGULATIONS ADOPTED SHALL ALLOW AN EMPLOYING

23 UNIT WITH 25 OR FEWER FULL-TIME EQUIVALENT EMPLOYEES TO PAY AN

24 ESTIMATED CONTRIBUTION FOR THE CURRENT CALENDAR YEAR IN AN AMOUNT

25 EQUAL TO THE TOTAL CONTRIBUTIONS PAID BY THE EMPLOYING UNIT FOR THE

26 IMMEDIATELY PRECEDING CALENDAR YEAR.

27 (II) THE ESTIMATED CONTRIBUTION SHALL BE PAYABLE IN 428 EQUAL QUARTERLY PAYMENTS.

 (III) AT THE END OF THE CALENDAR YEAR, THE ACTUAL AMOUNT OF THE CONTRIBUTION OWED BY THE EMPLOYING UNIT SHALL BE CALCULATED AND THE EMPLOYING UNIT SHALL:

5 2. RECEIVE A REFUNI) IF AN OVERPAYMENT OCCURRED.
6 [(2)] (3) In accordance with regulations adopted by the Secretary, an 7 employing unit shall:	
8 (i) submit to the Secretary periodic reports for determination of the 9 amount of contributions due; and	
10 (ii) pay the contribution.	
11 [(3)] (4) For payment of contributions, a	fractional part of a cent:
12 (i) that is less than one-half cent	shall be disregarded; and
13 (ii) that is one-half cent or more	shall be increased to 1 cent.
14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 October 1, 1996.
