A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County - Alcoholic Beverages**
3 **(Micro-Brewery)**

4 FOR the purpose of including Frederick County among those jurisdictions in which a
5 micro-brewery alcoholic beverages license may be issued; and generally relating to
6 alcoholic beverages in Frederick County.

7 BY repealing and reenacting, with amendments,
8 Article 2B - Alcoholic Beverages
9 Section 2-208
10 Annotated Code of Maryland
11 (1994 Replacement Volume and 1995 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article 2B - Alcoholic Beverages**

15 2-208.

16 (a) There is a Class 7 micro-brewery (on- and off-sale) license.

17 (b) The license shall be issued:

18 (1) By the State Comptroller;

19 (2) Only in the following jurisdictions:

20 (i) Allegany County;

21 (ii) Baltimore City;

22 (iii) Baltimore County;

23 (iv) The City of Annapolis;

24 (v) Anne Arundel County;

25 (vi) The thirteenth election district of Carroll County;

26 (vii) Charles County;

1 (viii) Dorchester County;

2 (ix) FREDERICK COUNTY;

3 (X) Howard County; and

4 [(x)] (XI) Prince George's County; and

5 (3) Only to a holder of a Class B beer, wine and liquor (on-sale) license that
6 is issued for use on the premises of a restaurant located in a jurisdiction listed in
7 paragraph (2) of this subsection.

8 (c) (1) A holder of a Class 7 micro-brewery license:

9 (i) May brew and bottle malt beverages at a single location; and

10 (ii) May not brew more than 10,000 barrels of malt beverage each
11 calendar year.

12 (2) In Allegany County only, the holder of a Class 7 license:

13 (i) May brew in one location and may contract for the bottling of the
14 malt beverage in another location; and

15 (ii) Need not meet the hotel/motel requirements for a Class B beer,
16 wine and liquor licensee but shall meet the requirements for those Class B restaurants.

17 (d) (1) The on-sale privilege authorizes the holder to sell at retail beer brewed
18 under this license to customers for consumption on the licensed premises.

19 (2) The off-sale privilege authorizes the holder to sell and deliver beer
20 brewed under this license to:

21 (i) Any wholesaler licensed under this article to sell beer in this State;
22 or

23 (ii) Any person who is located in a state other than Maryland who is
24 authorized under the laws of that state to receive brewed beverages.

25 (3) (I) [In] THIS PARAGRAPH APPLIES ONLY IN the City of Annapolis,
26 Anne Arundel County, Baltimore City, Baltimore County, Charles County, FREDERICK
27 COUNTY, Howard County, and Prince George's County [only, the].

28 (II) THE holder may sell at retail beer brewed under this license to
29 customers for consumption off the licensed premises in refillable containers that are
30 sealed by the micro-brewery licensee at the time of each refill.

31 (e) A holder of a Class 7 micro-brewery license:

32 (1) May not own, operate or be affiliated with any other manufacturer of
33 beer; and

34 (2) Notwithstanding § 2-201(b) of this article, may not be granted a
35 wholesale alcoholic beverages license.

1 (f) The hours and days for consumer sales under this license are as established
2 for a Class B license in the respective jurisdictions listed in subsection (b)(2) of this
3 section.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 1996.
