BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 16 MARYLAND, That the Laws of Maryland read as follows: 17 **Article - Transportation** 18 12-104.2. 19 (A) IN THIS SECTION, "IMPROPERLY REGISTERED MOTOR VEHICLE" MEANS 20 ANY MOTOR VEHICLE THAT: (1) IS OWNED BY A PERSON WHO RESIDES IN THE STATE; BUT 21

- 2 (B) THE MOTOR VEHICLE ADMINISTRATION SHALL ESTABLISH AN
- 3 INCENTIVE PROGRAM FOR LOCAL LAW ENFORCEMENT AGENCIES TO ENCOURAGE

- 6 (C) (1) THE INCENTIVE PROGRAM SHALL PROVIDE FOR A REWARD FOR A 7 CONVICTION FOR IMPROPER REGISTRATION.
- 8 (2) THE REWARD SHALL BE GIVEN TO THE LOCAL GOVERNMENTAL
- 9 ENTITY THAT EMPLOYS THE LAW ENFORCEMENT OFFICER WHO ISSUED THE
- 10 CITATION FOR THE IMPROPERLY REGISTERED MOTOR VEHICLE.
- 11 (3) THE REWARD SHALL CONSTITUTE 50% OF ANY EXCISE TAX
- 12 COLLECTED BY THE ADMINISTRATION FOR REGISTRATION OF THE MOTOR
- 13 VEHICLE UNDER TITLE 13 OF THIS ARTICLE.
- 14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 15 January 1, 1997.
